Friday, the 27<sup>th</sup> October, 1972.

10:00 A.M.

1. Unstarred Questions Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 14, 18, 19, 20, 21, 22, 23, 24, 25 and 29 were laid on the tables of the members.
2. Unstarred Question Nos. A-11, A-12, A-13, A-14, A-18 were orally answered by the Ministers concerned, the rest Nos. 24, 33 and 85 were laid on the Table of the House.
3. Voting on Demands:
  - (a) The Minister i/c Agriculture etc., Pu R.Thangliana, moved that Demand no. 16 (Agriculture, Animal Husbandry and Forest/Soil Conservation) for a total of Rs. 76,50,630/- be passed. The discussion was joined by Pu Lalhlira, Pu J.Thanghuama, Pu Hrangaia, Pu Chawngkunga, Pu Zalawma, Pu Ch.Saprawnga, Pu Vanlalhruaia, Pu Sangchhum, Pu Lalkunga, Pu K.L.Rochama and the Minister in-charge. The Demand was unanimously passed at 12:42 hours.
  - (b) The Minister i/c Development, Pu R.Thangliana moved that Demand No. 17 (Rural Development, Co-operation and Community Development) for Rs. 42,02,220/- be passed. Members-Pu Lalsangzuala, Pu J.Thanghuama, Pu Ch.Saprawnga, Pu Ngurdawla, Pu K.L.Rochama, Pu Dotinaia, Minister i/c Development and Dy. Minister i/c Co-operation took part in the discussion. The Demand was unanimously passed at 1325 hours.

(c) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 19 (Miscellaneous Social Development Organisation) for Rs. 16,36,800/- be passed. Members Pu R.Zoliana, Pu J.Thanghuama, and the Chief Minister took part in the discussion. The Demand was unanimously passed at 1410 hours.

(d) The Minister i/c Finance, Pu Khawtinkhuma, moved that Demand No. 18 (Industries and Employment & Labour) for Rs. 17,72,180/- may be granted. Members Pu Lalsangzuala, Pu Ch.Saprawnga, Pu J.Thanghuama, Pu Zalawma, Pu K.L.Rochama, Pu Hrangaia and the Minister in-charge took part in the discussion. The Demand was unanimously passed at 1452 hours.
