1. Starred Questions: Nos. 36, 37, 38, 39, 40, 41, 44, 45, 46, 47, 48 and 88 were orally answered. Starred Question No. 19 (b) was not orally answered as the member putting the question was absent when he was called; the answer was placed on the Table of the House.

2. Voting on Demands:

(a) Hon. Minister, Finance etc. Pu Khawtinkhuma, moved that Demand No. 1 for Rs. 3,50,000/- for Land Revenue Department be granted.

Pu Lalsangzuala, Pu Ch.Saprawnga, Pu J.Thanghuama, Pu C.Lalruata, Pu Vanlalhruaia, Pu J.Ngurdawla, Pu Hrangaia, Pu K.L.Rochama, Pu Lalkunga, Pu Zalawma, Finance Minister and the Chief Minister took part in the discussion and the demand was unanimously passed at 11:37 hours.

(b) Hon. Minister, Transport etc., Pu R.Thangliana moved that Demand No. 3 (Taxation on vehicles) for Rs. 30,480/- be granted. Pu Sangchhum, Pu

J.Thanghuama and the Minister (Transport) took part in the discussion and the demand was unanimously passed at 11:55 hours.

(c) Hon. Minister, Finance etc., Pu Khawtinkhuma moved that Demand No. 6 (Stamps) for Rs. 20,000/- be granted. Pu J.Thanghuama, Pu K.L.Rochama, Pu Lalsangzuala, Pu Hrangvela, Pu Chawngkunga and Minister (Finance) took part in the discussion, and the demand was passed unanimously at 1203 hours.

(d) Hon. Minister, Finance etc., Pu Khawtinkhuma moved that Demand No. 33 (Commuted Pension) for Rs. 20,000/-be granted. It was unanimously passed without discussion at 1205 hours.

(e) Hon. Minister, Finance etc., Pu Khawtinkhuma, moved that Demand No. 35 (Loans & Advances) for Rs. 1,91,62,000/- be granted. Pu J.Thanghuama, Pu C.Lalruata, Pu Hranggaia, Pu Lalsangzuala, Pu Ch.Saprawnga, Pu Zalawma and Minister (Finance) took part in the discussion, and the grant was unanimously passed at 12.50 hours.

Voting on Demands (Continued):

(f) Hon. Minister, Education etc., Pu Vaivenga, moved that Demand No. 14 (Education) for Rs. 1,71,34,770/- be granted. Pu C.Lalruata, Pu Sapliana, Pu Lalkunga, Pu Ch.Saprawnga, Pu Zalawma, Pu J.Thanghuama, Pu J.Ngurdawla, Pu Hranggaia, Pu K.L.Rochama, Pu Hiphei and the Minister (Education) took part in the discussion. Members of the opposition (4) staged a walk-out before voting was done to protest when assurance could not be given that 200 L.P. Teachers appointed by the Mizo District Council on the eve of that Council's dissolution should be given priority

in recruitment. When voting was done, none raised objection to the passing of the grant, and the grant was passed at 3:45 P.M.

(g) Hon. Minister, (Health), Pu Vaivenga, moved that Demand No. 15 (Health, Public Health and Family Planning) for a total of Rs. 1,28,85,560/- be granted. Pu Ch.Saprawnga, Pu Dotinaia, Pu J.Thanghuama, Pu Vanlalhruaia, Pu Lalkunga, Pu C.Lalruata, Pu F.Hrangvela, Pu Sapliana and Minister (Health) took part in the discussion. The grant was passed unanimously at 5:05 P.M.
