1. Starred Questions nos. 42, 43, 49, 50, 51, 52, 53 A-17, 22, 23, A-1, A-15 and A-19 were orally answered.

2. Voting on Demands:

- (a) The Minister i/c Transport etc., Pu R.Thangliana, moved that Demand no. 13 (Miscellaneous) for Rs. 39,23,510/- be passed. In the discussion which followed members- Pu Lalsangzuala, Pu R.Zoliana, Pu K.L.Rochama, Pu J.Thanghuama, Pu Ch.Saprawnga, Pu Vanlalhruaia and the Minister incharge took part. The demand was unanimously passed at 12:00 noon.
- (b) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 23 (Famine Relief Operation Pension and other Retirement Benefits) for Rs. 65,58,000/- be passed. In the discussion which followed members-Pu J.Thanghuama, Pu R.Zoliana, Pu Lalsangzuala, Pu Ch.Saprawnga and the Chief Minister took part, and the Demand was unanimously passed at 12:45 P.M.
- (c) The Minister i/c Supply etc., Pu R.Thangliana, moved that Demand No. 34 (Capital Outlay on Govt. Trading) for Rs. 3,68,01,000/- be passed.

Member Pu Lalsangzuala and the Minister incharge spoke on the Demand, which was unanimously passed at 13:00 P.M.

Afternoon (14:00 hours)

- (d) The Minister i/c Judiciary etc., Pu Vaivenga, moved that Demand No. 10 (Administration of Justice) for Rs. 2,63,650/- be passed. Member Pu Lalsangzuala and the Minister in-charge spoke on the Demand, which was unanimously passed at 14.16 hours.
- (e) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 8 (Parliament, Union/State Legislature and Election) for Rs. 9,55,050/-be passed. Members-Pu Ch.Saprawnga, Pu Sapliana, Pu J.Ngurdawla and the Chief Minister talked on the Demand, which was unanimously passed at 14.35 hours.
- (f) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 9 (General Administration) for Rs. 67,95,210/- be passed.
- (g) Member Pu K.L.Rochama, Pu J.Thanghuama, Pu Sangchhum, Pu Ch.Saprawnga, Pu R.Thangliana (Minister), Pu Lalkunga, Pu Hrangaia and the Chief Minister spoke on the Demand. The Demand was unanimously passed at 14.45 hours.
- (h) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 11 (Jails) for Rs. 4,40,400/- be passed. Members-Pu J.Thanghuama, Pu R.Zoliana, Pu K.L.Rochama, Pu Lalkunga, Pu F.Hrangvela, Pu Lalsangzuala and he Chief Minister took part in the discussion. The demand was unanimously passed at 1615 hours.
- (i) The Chief Minister, moved that Demand No. 12 (Police) for Rs. 1,54,65,520/- may be passed. Members Pu J.Thanghuama, Pu Lalsangzuala, Pu Ch.Saprawnga, Pu K.L.Rochama, Pu Sapliana and the Chief Minister took part in the discussion. The Demand was passed unanimously at 1706 hours.

The meeting was adjourned for the day till 10:00 A.M. on Friday, the 27th Oct '72.
