1. <u>Starred Questions</u>: Nos. 75, 76, 77, 78, 79, 80, 81, 82 and 83 were orally answered by the Ministers concerned.

2. Voting on Demands:

- (a) The Chief Minister (i/c Public Works) moved that Demand No. 21 (Public Works and Capital outlay on Public Works within Revenue Accounts) for a total of Rs. 1,43,63,800/- be passed. After discussion where members-Pu R.Zoliana, Pu Lalsangzuala, Pu Ch.Saprawnga, Pu J.Thanghuama, Pu Vanlalhruaia, Pu Lalrinliana, Pu Zalawma, Pu K.Sangchhum, Pu Hrangvela, Pu Saitlawma and the Chief Minister took part, the Demand was unanimously passed at 12:28 P.M.
- (b) The Chief Minister (i/c Public Works) moved that Demand No. 30 (Capital outlay on Public Works) for a grant of Rs. 81,09,000/- be granted. The discussion which followed was joined by Pu R.Zoliana, Pu J.Thanghuama, Pu Lalsangzuala, Pu Lalkunga and the Chief Minister. The Demand was unanimously passed at 13:05 P.M.
- (c) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 22 (Ports & Postage and Road Transport Organisation) for a total of Rs.3,40,000/- be granted. In the discussion which ensued, members-Pu Chawngkunga, Pu

Sangkhuma, Pu Ngurdawla, Pu Lalkunga and Pu Saitlawma took part, and the Minister i/c Transport, Pu R.Thangliana wound up the discussion. The Demand was unanimously passed at 13:35 P.M.

Afternoon:

Voting on Demands:

- (d) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 24 (Printing and Stationery) for Rs. 2,22,840/- be granted. Members-Pu R.Zoliana, Pu Lalsangzuala spoke on the demand. The Chief Minister closed the discussion and the Demand was unanimously passed at 1450 hours.
- (e) The Chief Minister, Pu Ch.Chhunga, moved that Demand No. 25 (miscellaneous Expenditure) for Rs. 1,27,42,170/- be passed. Members-Pu C.Lalruata, Pu J.Thanghuama, Pu Saitlawma, Pu Lalsangzuala, Pu Hrangaia, Pu Sapliana, Pu Lalkunga, Pu K.L.Rochama, Pu Zalawma, Pu Chawngkunga, the Chief Minister and the Minister, Pu Thangliana spoke on the Demand. The Demand was unanimously passed at 1616 hours.
- (f) The Minister i/c Power & Electricity, Pu Vaivenga, moved that Demand No. 29 9Capital outlay on Power & Electricity) for Rs. 54,98,000/- be passed. Members-Pu Lalsangzuala, Pu C.Lalruata, Pu J.Thanghuama, Pu Hrangaia, Pu Saitlawma, Pu L.P.Thangzika, Pu Zalawma, Pu Lalrinliana, Pu Vanlalhruaia, Minister i/c Pu Vaivenga spoke on the Demand.

3. APPROPRIATION BILL, 1972.

The Hon. Minister i/c Finance introduced "The Appropriation (No. 1) Bill, 1972" and moved that it be passed. U/S 25 of the U.T. Act, 1963 (as amended). The Bill was unanimously passed at 1715 hours.
