(Budget Session, 1973)

ASSEMBLY SUMMARY

TUESDAY, THE 20TH MARCH, 1973.

The Assembly met at 10 A.M.

The day was devoted for transaction of Private Members' Business.

1. <u>REPORT OF THE BUSINESS ADVISORY COMMITTEE</u>

The Speaker announced the Report of the Business Advisory Committee which sought to revise the earlier Calendar for the current Session of the Assembly.

Pu Ch.Saprawnga then moved the motion for adoption of the report of the Business Advisory Committee. The House unanimously adopted the motion and approved the Programme.

2. LAYING OF PAPERS

Pu Hiphei, Deputy Speaker and Chairman of the House Committee laid on the Table of the House the Report for Internal Working of the House Committee of the Mizoram Legislative Assembly.

3. PRIVATE MEMBERS' RESOLUTIONS

The resolution No. 1 standing in the name of Pu Sangkhuma was moved, which read as follows.

"This Assembly recommends that Government of Mizoram constitutes a Commission to consider and recommend to Government how and where new villages may be located."

The following Hon'ble Members also took part in the discussion on the resolution.

Thereafter, the Minister in-charge of L.A.D. Pu Vaivenga replied to the discussion.

The resolution was thereafter put to the House as a question, and it was adopted.

Another resolution No. 2 in the name of Pu R.Dotinaia was moved and he spoke on the resolution. The resolution read as follows: "This Assembly is of the opinion that the Government of Mizoram do take steps to establish a Hydel Project in Mizoram within the next Financial year."

Pu C.Lalruata moved an amendment to the resolution whereby he wanted to declare the words <u>'within the next Financial Year'</u> appearing at the end of the resolution, and he also spoke on his amendment. The amendment was, with the consent of the mover of the resolution Pu R.Dotinaia adopted. Thereafter, the discussion of the resolution was followed. The following Hon'ble Members took part in the discussion of the resolutions:

Thereafter, the Minister in-charge of Powers and Electricity, Pu Vaivenga also took part in the discussion on the resolution. The resolution was put to the House as a question and was unanimously adop0te din the amended form.

Pu C.Chawngkunga moved the resolution No. 3 standing in his name and spoke on the resolution. The resolution read as follows:

"This Assembly is of the opinion that the Government of Mizoram do take steps to control the Domestic Animals in Mizoram, if necessary, by Legislation." The other Hon'ble Members who took part in the discussion were:

The Minister in-charge Pu Vaivenga also took part in the discussion. When the Hon'ble Minister informed the House that a Bill on the subject was under preparation of the Department, he therefore requested the mover of the resolution to withdraw his resolution since the matter had already been taken up by the Government. Thereafter, the mover of the resolution expressed his willingness to withdraw his resolution with the permission of the House. The resolution was therefore withdrawn. The mover of the resolution Nos. 4, 5, 6 & & were absent in the House. So, the resolution in their names stood withdrawn.

As regards resolution Nos. 8 and 9, the Speaker pointed out the provision of the proviso to sub-rule (3) of Rule 115 of the Assembly Rules, whereby only one resolution of a Member should be included in one day for discussion. As the Hon'ble Member had already moved his resolution No. 1 which was also adopted in the House, the Speaker pointed out that unless the relevant Rule was suspended under the provision of Rule 316, he could not allow the Hon'ble Member to move his another resolution standing in his name. As no one was willing to move a motion for suspension of the Rule the resolutions were treated as withdrawn.

ADJOURNMENT

The Assembly was then adjourned at 3:00 P.M. to meet again at 10:00 A.M. on Friday, the 23rd March, 1973.
