CALLING ATTENTION NOTICE UNDER RULE 54

Pu R.Dotinaia, M.L.A. called the attention of the Minister in-charge of Supply under Rule 54 of the Rules of Procedure and Conduct of Business in the Assembly to the news item published in a local paper, 'TAWRH BAWM' dated the 13th March, 1973, under the caption "ZAWNGA TUARAI NGAUVIN" relating to non-issue of rice and sugar to the Government Fair Price Shop Dealers in Aizawl to which the Minister in-charge of Supply made a short statement.

REPORT OF RULES COMMITTEE
