ASSEMBLY SUMMARY

Friday, the 11th October, 1974.

11:00 A.M.

1. Starred Questions:

Starred Questions Nos. 105, 106, 107, 108, 109, 110 and 111 with supplementaries thereto were orally answered during the Question hour.

The remaining Starred Questions from Nos. 112 to 115 listed for the day but not called for lack of time will be circulated to the Hon'ble Members under sub-rule (5) of Rule 36 of the Rules of Procedure and Conduct of Business in the proceedings of the day.

2. Announcement by the Speaker:

The Speaker announced names of new members appointed by him for 8 (eight) Assembly Committees for a period of one year from 1.10.74. (List enclosed at Flag 'A').

3. Bye Election for a member of Estimates Committee:

The Speaker declared that Pu Lalkunga was elected uncontest to fill up one casual vacancy caused by the appointment of Pu Lalsangzuala, a Minister Pu Lalkunga shall hold office for the unexpired portion of the term.

4. Calling Attention:

Pu Saitlawma called the attention of the Chief Minister, in-charge of Political Department under Rule 57 of the Rules of Procedure and Conduct of Business in the Mizoram Legislative Assembly to a newspaper report apperating in "ZAWL KHAWPUI" dated 14th September, 1974 relating to stoppage and checking of the Car of Pu P.B. Nikhuma, Deputy Minister by an Army Captain while he was touring, flying the National Flag on his Car. As the Chief Minister was indisposed to attend the Assembly, the Minsiter for Parliamentary Affairs made a statement.

5. Government Bills-Consideration & Passing:

(A) Pu Lalsangzuala, Minister for Parliamentary Affairs on behalf of Pu Ch. Chhunga, Chief Minister, who was not attending Assembly due to his illness, moved that "The Mizoram Official Language Bill, 1974" be considered.
