1. Starred Questions:

The Speaker presented the Report of the Business Advisory Committee which was adopted by the House on a motion moved by Pu Lalsangzuala, Minister for Parliamentary Affairs.

5. Announcement by the Speaker:

The Speaker announced that he received a letter from the Secretary, Mizo Union Party requesting him to allot separate bench for two members, Shri R.Dotinaia and Shri Sangkhuma who will discontinue to join Congress Legislature Party, and that he had allotted them separate bench. He further announced that he would give ruling whether these two members would be recognized as Opposition Group or otherwise.

6. Motion on breach of Privilege:

The Speaker announced that he received a motion on breach of Privilege submitted by Pu R.Zoliana, member, alleging that the Magistrate of Aizawl had contravened Rules 164 and 165 of the Rules of Procedure etc., by his failure to intimate the Hon.ble Speaker of the arrest on 25th July, 1974 and release (on personal bond) of a Member of the Legislature, Shri C.Lalruata, and thus committed breach of privilege of the House.

Shri R.Zoliana was allowed to move the motion and the Speaker reserved his ruling on it, awaiting a report from the Home Department.
