1. Questions:

Starred Question Nos. 117, 118, 119, 120, 121, 122, 123 and 124 with supplementaries thereto were orally answered.

Under sub-rule 5 of Rule 37 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, Starred Questions Nos. 125, 126, 127, 128, 129, 130, 131, 132, 133, 134, 135, 136, 137, 138, 139, 140, 141 and 142 which were not called within the Question Hour will be circulated to the Members with their replies.

2. Short Notice Questions:

Short Notice Question No. 1 submitted by Pu Saitlawma under Rule 51 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, regarding the recent death of Shri Lalchhhawnkima whilst in the custody of Security Forces at Hnahthial on 16.3.1975 as asked. Pu Ch.Chhunga, Chief Minister orally answered the question.

### 3. Laying of Paper:

Under the proviso of Rule 284 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, Pu R. Thangliana, Minister laid the following paper on the Table of the House:-

“List of Land Reclamation work (District wise) taken up in Mizoram during the last three years.”

### 4. Government Bill Consideration and Passing:

(a) “The Lushai Hills District (Village Councils) Amendment Bill 1975”, already introduced by Pu P.B.Nikhuma, Deputy Minister on 25.3.1975 was considered, discussed and passed.

(b) “The Mizoram Roadside Land Control Bill 1975”, already introduced by Pu Lalsangzuala, Minister (on behalf of Pu Ch. Chhunga, Chief Minister) on 29.3.1975 was taken up for consideration etc. The Chief Minister Pu Ch. Chhunga, member-in-charge proposed that the Bill be referred to Select Committee as provided Vide Rule 77 (b) of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly. The House agreed to refer the Bill to the Select Committee.
