1. Questions:

- (a) Starred Question Nos.103, 104, 105, 106, 107, 108, 109 and 110 with supplementaries thereto were orally answered.

Under sub-rule 5 of Rule 37 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, Starred Questions Nos. 111, 112, 113, 114, 115 and 116 which were not called within the Question Hour will be circulated to the Members with their replies.

- (b) Unstarred Question No. 15 with answers was placed on the Table.

2. Calling Attention:

Pu R.Dotinaia called the attention of the Supply Minister under Rule 57 of the Rules of Procedure and Conduct of Business in the Mizoram Legislative Assembly, to a Newspaper report appearing in "ROMEI" dated 25.3.1975, relating to the low supply position.

The Minister i/c Supply gave a statement on it.

3. Voting on Demands for Grants (1975-76):

(a) Demands Nos. 1, 2, 3, 9, 12, 17, 28, 34, 43 and 53 were together moved by the concerned Minister Pu Lalsangzuala. They were considered, voted and passed as demanded.

(b) Demands Nos. 30, 37 and 38 were together moved by the concerned Deputy Minister Pu Zalawma. They were considered, discussed and passed as demanded.

(c) Demands Nos. 20, 24 and 52 were together moved by the concerned Deputy Minister Pu P.B.Nikhuma. They were considered, discussed, voted and passed as demanded.

(d) Demands Nos. 4, 5, 13, 15, 16, 19, 29, 25, 40, 50, 55, 56, 57 and 58 were together moved by the concerned Minister, Pu Ch. Chhunga, and Chief Minister. The demand were considered, discussed, voted and passed as demanded.

4. THE APPROPRIATION (NO. 2) BILL, 1975 (BILL NO. 3 OF 1975):

The Appropriation (No. 2) Bill, 1975 was introduced by the Finance Minister, Pu K.T.Khuma. It was considered and passed.

5. Adjournment:

The House was adjourned at 2125 hours till 11:00 A.M. on Tuesday, the 1st day of April, 1975.
