1. Questions:

(a) Starred Question Nos. 21 to 30 listed for the day with supplementaries thereto was orally answered.

2. Private Members' Bill:

Pu Saitlawma, M.L.A. Introduced "The Mizoram Union Territory Legislature Members' (Removal of Disqualification) Bill, 1975" and moved that it be taken into consideration.

Pu Saitlawma, Member-in-charge of the Bill wound up the discussion. On a motion moved by the Member-in-charge of the Bill, the Bill was passed unanimously without amendment.

### 3. Government Bill:

Under Rule 29 (3) of the Rules of Procedure, the Hon'ble Speaker allowed Pu Vaivenga, Minister-in-charge, Revenue to seek permission for introduction of "The Mizoram Trading by Non-Tribals (Regulation) (Amendment) Bill, 1975, (Bill No. 7 of 1975). On permission being given, the Bill was introduced. The Speaker announced that the Bill would be taken up for consideration on Monday, the 29<sup>th</sup> September, 1975.

### 4. Private Resolutions:
