## **ELECTION OF SPEAKER**

- In pursuance of sub-rule (1) of Rule 7 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, the Lt. Governor (Administrator) of Mizoram has been pleased to fix Wednesday, the 9<sup>th</sup> May, 1984 for holding election to the Office of the Speaker of the Assembly.
- 2. In this connection, attention of members is invited to sub-rules (2) to (8) of Rule 7 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly which is reproduced below-
  - " (2) At any time before 3:30 P.M. on the day preceding the date so fixed, any member may nominate another member for election by delivering to the Secretary a nomination paper signed by himself as prosper and by a third member as seconder and stating:-
  - (a) The name of the member nominated; and
  - (b) That the prosper has ascertained that such member is willing to serve as Speaker, if elected.

- (3) The nomination paper shall be delivered to the Secretary either by the candidate himself or by the prosper or seconder in person.
- (4) In the case of a new Assembly, the member appointed by the Administrator to perform the duties of the office of Speaker pending the election of a Speaker and in any other case the Deputy Speaker or other Member presiding shall read out to the Assembly the names of the members who have been duly nominated together with those of the proposers and seconders and if only one member has been so nominated, shall declare that member elected. If more than one member has been so nominated, the Assembly shall proceed to elect a Speaker by ballot, and in case of two candidates the candidate obtaining the larger number of votes shall be declared elected. In case of equality of votes, it shall be determined by the drawing of lots.
- (5) For the purpose of sub-rule 94), a member shall not be deemed to have been duly nominated or be entitled to vote if he and his prosper and seconder have not, before reading out of the names by the person reading out of the names by the person presiding, made the oath or affirmation as members of the Assembly.
- (6) Where more than two candidates have been nominated and at the first ballot-
- (a) one of such candidates, obtains more votes than the aggregate votes obtained by the other candidates he shall be declared elected;

- (b) If no candidate obtaining more votes than the aggregate votes obtained by the other candidates, the candidate who has obtained the smallest number of votes shall be excluded from the election and the balloting shall proceed, the candidate obtaining the smallest number of votes at each ballot being excluded from the election, until one candidate obtains more votes than the remaining candidate or than the aggregate votes of the remaining candidates, as the case may be.
- (7) Where at any ballot any of three or more candidates obtain equal number of votes and one of them has to be excluded from the election under sub-rule (6), the determination as between the candidates whose votes are equal of the candidate who is to be excluded shall be by drawing of lots.
- (8) A nomination paper may be withdrawn by the candidate or the prosper before the Assembly meets on the day fixed for the election of the Speaker."
- 3. Members are also informed that as per sub-rule (2) of Rule 7, notices of motions for election of the Speaker will be received till 3:30 P.M. on Tuesday, May 8, 1984.

## **ELECTION OF DEPUTY SPEAKER**

- 1. In pursuance of sub-rule (1) of Rule 8 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, the Speaker has been pleased to fix Wednesday, the 9<sup>th</sup> May, 1984 for holding election to the Office of the Speaker of the Assembly.
- 2. In this connection, attention of members is invited to sub-rules (2) to (9) of Rule 8 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly which is reproduced below-
  - " (2) At any time before 3:00 P.M. on the day preceding the date so fixed, any member may nominate another member for election by delivering to the Secretary a nomination paper signed by himself as prosper and by a third member as seconder and stating:-
  - (c) The name of the member nominated; and
  - (d) That the prosper has ascertained that such member is willing to serve as Speaker, if elected.

- (3) The nomination paper shall be delivered to the Secretary either by the candidate himself or by the prosper or seconder in person.
- (4) The election shall take place at a meeting of the Assembly.
- (5) On the date fixed for election the Speaker or the person presiding shall read out to the Assembly the names of the members who have been duly proposed together with the names of their proposers and seconders, and if only one member has been so proposed for election, shall declare that person duly elected. If more than one person has been so proposed, the Assembly shall proceed to elect a Deputy Speaker by ballot, and in case of two candidates the candidate obtaining the larger number of votes shall be declared elected.
- (6) For the purpose of sub-rule (5) a member shall not be deemed to have been duly nominated or be entitled to vote if he and his proposer and seconder have not, before the reading out of the names by the person presiding made the oath or affirmation as members of the Assembly.
- (7) When more than two candidates have been nominated and at the first ballot-
- (a) one of such candidates obtains more votes than the aggregate votes obtained by the other candidates he shall be declared elected;
- (b) if no candidate obtains more votes than the aggregate votes obtained by the other candidates, the candidate who has obtained the smallest number of votes shall be excluded from the election,

until one candidate obtains more votes than the remaining candidate or than the aggregate votes of remaining candidates, as the case may be.

- (8) Where at any ballot anyof the three or more candidates obtain an equal number of votes and one of them has to be excluded from the election under sub-rule (7), the determination as between the candidates whose votes are equal of the candidate who is to be excluded, shall be by drawing of lots.
- (9) A nomination paper may be withdrawn by the candidate or the proposer before the Assembly meets on the day fixed for the election of the Deputy Speaker."
- 3. Members are also informed that as per sub-rule (2) of Rule 8, notices of motions for election of the Speaker will be received till 3:00 P.M.

- 3. On arrival at the Gate of the Assembly House the Lt. Governor will be received by the Speaker and the Secretary of the Assembly. Therefore, the Lt. Governor will be conducted to the Assembly Hall in procession and his entry will be announced by the Marshall.
- 4. All Members will rise in their seats as soon as the announcement is made. Then the 1<sup>st</sup> Bn. Assam Rifles Band Party will play the National Anthem and the Members will resume their seats after the Lt. Governor has taken his seat.

- 1. Members are informed that as provided in Section 11 of the Government of Union Territories Act, 1963 (20 of 1963) and in pursuance of Notification No. MAL. 39/84/1 dated the 7<sup>th</sup> May, 1984, every member shall, before taking his seat, make and subscribed before the person appointed in that behalf by the Lt. Governor, an oath or affirmation according to the form set out for the purpose.
- 2. The following procedure will be followed in connection with making and subscribing oath or affirmation at the first sitting of the Assembly which is scheduled to commence on the 9<sup>th</sup> May, 1984 at 10:30 A.M. at Assembly House, Aizawl.
  - (i) Members will assemble in the Assembly Hall by 10:30 A.M.
  - (ii) The proceeding will begin with the Speaker pro-tem in the chair at the appointed time.
  - (iii) Secretary will read out the appointment order of Speaker pro-tem.

- (iv)Members will make and subscribed oath or affirmation in the following order:-
- (a) Chief Minister
- (b) Ministers
- (c) Other members-Constituency-wise
  - (v) On the name of a member being called by an officer of the House, the member will proceed to the Secretary's table, where a copy of the form of oath or affirmation (in Mizo or in English as may be desired) will be handed over to him.

  - (vii) The Member will then shake hands with the Speaker pro-tem and pass over from behind the Speaker pro-tem to the other side to sign the Roll of Members kept by the Under Secretary.
  - (viii) The Member after signing the Roll of Members will go to his seat without crossing the floor between the Speaker pro-tem and the Members.

## **RULES TO BE OBSERVED BY MEMBERS**

Rule No. 265 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly is reproduced below for information of Members:

While the House is sitting, a member-

- (i) Shall not read any book, newspaper or letter except in connection with the business of the House;
- (ii) Shall not interrupt any member while speaking by improper expression or noises in any other improper manner;
- (iii) Shall bow to the Chair while taking or leaving his seat;
- (iv) Shall not pass between the Chair and any member who is speaking;
- (v) Shall not leave the House when the Speaker is addressing the House;
- (vi) Shall always address the Chair;
- (vii) Shall maintain silence when not speaking in the House;

- (viii) Shall keep to his usual seat;
- (ix) Shall not applaud when a stranger enters any of the Galleries, or the Special Box;
- (x) Shall not while speaking, make any reference to the strangers in any of the Galleries;
- (xi) Shall not obstruct proceedings, hiss or interrupt and shall avoid making running commentaries when speeches are being made in the House.
