 Pu Lal Thanhawla, Chief Minister & Leader of the House made obituary reference on the death of Shri Arobindo Ghosh, Member of Parliament (Rajya Sabha) who passed away on the 7<sup>th</sup> November, 1984. The House stood in silence for a minute as a mark of respect to the departed soul.

#### **ADJOURNMENT MOTION**

 Brig. T.Sailo, Leader of the Opposition Party enquired about his adjournment motion given on 13.11.1984. The Speaker informed him that his adjournment motion was rejected on grounds of Rule 60 (viii) of Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly.

Pu Zairemthanga was also informed by Speaker that his adjournment motion was rejected on the same grounds.

# 4. MOTION

Pu Zalawma, Chairman Estimates Committee moved-

"That the Member of this House do proceed to elect in the manner required by sub-rule (3) of Rule 182 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly a member to fill one vacancy in the Committee on Estimates caused by an appointment of Pu Liansuama as Minister of State on 16.6.1984."

5. Pu K.Biakchungnunga, Chairman, Public Accounts Committee moved-

"That the Members of this House do proceed to elect in the manner required by sub-rule (3) of Rule 182 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly a member to fill one vacancy in the Public Accounts Committee caused by an appointment of Pu Hiphei as Minister of State on 16.6.1984.

The motion was adopted and appointed Pu F.Lalchhawna as Member of the Public Accounts Committee in place of Pu Hiphei.

6. Pu Lalhuthanga moved an amendment to Rule 12 of the Mizoram Pension of Members of the Legislative Assembly Rules, 1984 as follows:-

"12. Final Decision: If any controversy arises as to the entitlement of Pension or interpretation of these rules, the matter shall be referred to Government in the Law & Judicial Department who shall decide the matter and such decision in the matter shall be final."

The mover of the motion amended his own amendment in which form it was adopted as below-

"I any controversy arises as to the entitlement of Pension or interpretation of these rules, the matter shall be referred to Government in the Law & Judicial Department who shall decide the matter in consultation with the Finance Department and such decision in the matter shall be final."
