- (4) The Mizoram Appropriation (No. 8) Bill, 1984 for Rs. 26,75,214.00
- (5) The Mizoram Appropriation (No. 4) Bill, 1984 for Rs. 3,03,78,427.00 pertaining to year 1977, 1978, 1979, 1980, and 1981 were passed unanimously.
