1. Venue : Hon'ble Speaker's Chamber, Assembly House, Aizawl.
2. Time : 11:00 A.M. on the 20<sup>th</sup> August, 1984.
3. The nominated Members, other members and invitees will assemble at the Speaker's Chamber by 11:00 A.M.
4. The Hon'ble Speaker will enter his chamber at 11:00 A.M.
5. The Hon'ble Speaker will ask the Secretary to read out the Government of India's Notification nominating the three persons and authorization to administer Oath/Affirmation to Hon'ble Speaker by Lt. Governor (Administrator) Mizoram on his behalf.
6. The Secretary will call the name of the Nominated Members according to the order in the Notification.
7. On his/her name being called by the Secretary the Member shall proceed to the Secretary's table where a copy of the form of Oath/Affirmation will be handed over to him/her.
8. The member will face the chair and make the Oath/Affirmation.

9. The Member will then sign the form of Oath/Affirmation kept at the Secretary's table.
10. The Member will shake hands with the Speaker.
11. The Member will then go to the other table where the Roll of Members is kept with the Under Secretary and sign therein.
