2. PRIVILEGE MOTION

SHRI F. LALRAMLIANA raised, under rule 145 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly a question of Privilege against the Editor of daily Newspaper ZAWLAIDI for publishing the following on 27th September, 1985 under the captain DR CHHURA HUANG-

Philosophy emaw Dr. Hial kaichin kan fing tawk bawk ang tih ring la i nung a ni mai.”
