1. QUESTIONS

Starred Questions No. 6 was asked and orally answered.

2. PRIVILEGE MOTION

Shri F.LALCHHAWNA raised a motion of privilege against the Editor of ZAWLAIDI for the news item published in the front page of ZAWLAIDI September 27, 1985 issued. The news item published under the caption "Assembly Session Mak Danglam" is as follows-
