## PRIVATE MEMBERS' RESOLUTION

The following is the relative precedence of Private members' Resolution balloted on 2.9.1986 under rule 122 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly.

1) Pu K. Biakchungnunga - to move

"This House requests the Govt. of India to restore Status Quo 21.1.1972 in the matter of administration of Tribal areas in the State of Mizoram by abolishing the existing autonomous Chakma District Council brought into being by imposition in 1972 out of political machination." 2) Pu Z.D. "This Assembly resolves that the Central Govt. be moved to bring all the Mizos inhabited contiguous areas into a singly administrative unit to form Greater Mizoram."

3) Pi K. Thansiami - to move

"This House resolves that the Govt. of Mizoram should, in due reverence for the wishes/sentiments of the large majority of the Mizo people immediately cancel all the existing Licenses relating to sale of I.M.F.L."

4) Pu J. Thanghuama to move

"This Assembly is of the opinion that the read Aizawl-Sialsuk-Thenzawl-Haulawng-Lunglei be declared as NATIONAL HIGHWAY in lieu of Aizawl-Serchhip-Lunglei BRTF road and the construction started immediately."

5) Pu F. Lalramliana to move-

"This Assembly highly appreciates the signing of peace accord between Govt. of India and Pu Laldenga, President, Mizo National Front and thereby putting an end to disturbances in Mizoram."

6) Pu J. Thanghuama to move-

"This Assembly is of the opinion that all the vacant posts, present and future under the Govt. of Mizoram be reserved cent per cent for the sons of the soil."

7) Pu Lalhlira to move-

"This Assembly is of the opinion that Hriangmual near Phuaibuang Village be made into Wildlife Sanctuary by the Govt. of Mizoram."

8) Pu R. Lalawia to move-

"This Assembly is of the opinion that the Memorandum of Settlement signed between the Govt. of India and Mr. Laldenga, representing the Mizo National Front be accorded with the warmest welcome."

9) Pu Lalhlira to move-

"This Assembly resolves that the Central Govt. be moved to bring all the Mizos inhabited areas into a single administrative unit to form Greater Mizoram."

"This Assembly is of the opinion that the road Aizawl-Sialsuk-Thenzawl-Haulawng-Lunglei be declared as National Highway in addition to Aizawl-Serchhip-Lunglei-BRTF road and the construction start immediately.:

## 11) Pu Zalawma to move-

"This Assembly resolves to place on record its appreciation of the Political Agreement signed by the Indian National Congress (I) and the Mizo National Front and also the Memorandum of Settlement signed between Govt. of India and Mizo National Front with great sense of gratitude. This clearly shows that our M.N.F. brothers who have been struggling Independence for Mizoram for the last two decades have now accepted the Constitution of India and acknowledged Mizoram as an internal part of India."

12) Pu Lalhlira to move-
