# PROGRAMME REGARDING OATH/AFFIRMATION BY MEMBERS

Members are informed that, as provided in section 11 of the Government of Union Territory Act, (Notification No. MAL. 19/78/1 1963, and in pursuance of the Order dated the 15<sup>th</sup> June, 1978) issued by the Lt. Governor in this regard, every member shall before taking his seat, make and subscribe before the person appointed in that behalf by the Lt. Governor, an oath or affirmation according to the form set out for the purpose.

- 2. The following procedure will be followed in connection with making and subscribing oath or affirmation at the first sitting of the Assembly which is scheduled to commence on the  $21^{st}$  June, 1978 at 10:30 A.M.
  - (i) Members will assemble in the Assembly Hall by 10:30 A.M.
  - (ii) The proceeding will begin with the Speaker pro tem in the Chair at the appointed time.
  - (iii) Members will make and subscribe oath or affirmation in the following order:
    - (a) Chief Minister;

- (b) Ministers;
- (c) Other Members, Constituency-wise
  - (iv) On the name of a Member being called by an officer of the House, the Member will proceed to the side of Secretary's table, where a copy of the form of oath or affirmation (in Mizo or in English as may be desired) will be handed over to him.
  - (v) The Member will face the Chair and make the oath or affirmation.
  - (vi)The Member will then sign the form of oath/affirmation and the Roll of Members kept at the Secretary's table.
  - (vii) The Speaker pro tem will then give the member permission to take his seat in the House.

#### **ELECTION OF DEPUTY SPEAKER**

In pursuance of sub-rule (1) of rule 8 of the Rules of Procedure of the Assembly, the Speaker has been pleased to fix Wednesday the 21<sup>st</sup> June, 1978 as the date for holding election to the office of the Deputy Speaker of the Assembly.

- 2. In this connection, attention of Members is invited to sub-rules (2) to (9) of Rule 8 of the Rules of Procedure of the Assembly which are reproduced below:
- " (2) At any time before 3:30 P.M. on the day preceding the date so fixed, any member may nominate another member for election by delivering to the Secretary a nomination paper signed by himself as prosper and by a third member as secondary and standing:-
  - (a) The name of the member nominated; and
  - (b) That the prosper has ascertained that such member is willing to serve as Speaker, if elected.
    - (3) The nomination paper shall be delivered to the Secretary either by the candidate himself or by the prosper or seconder in person.
    - (4) The election shall take place at a meeting of the Assembly.

- (5) On the date fixed for election the Speaker or the person presiding shall read out to the Assembly the names of the members who have been duly proposed together with the names of their prospers and seconders, and if only one member has been so proposed for election, shall declare that person duly election. If more than one person has been so proposed, the Assembly shall proceed to elect a Deputy Speaker by ballot, and in case of two candidates the candidate obtaining the larger number of votes shall be declared elected.
- (6) For the purpose of sub-rule (5) a member shall not be deemed to have been duly nominated or be entitled to vote if he and his proposer and seconder have not, before the reading out of the names by the person presiding made the oath or affirmation as members of the Assembly.
- (7) When more than two candidates have been nominated and at the first ballot-
  - (a) One of such candidates obtains more votes than the aggregate votes obtained by the other candidates he shall be declared elected;
  - (b) If no candidate obtains more votes than the aggregate votes obtained by the other candidates, the candidate who has obtained the smallest number of votes shall be excluded from the election and the balloting shall proceed, the candidate obtaining the smallest number of votes at each ballot being excluded from the election, until one candidate obtains more votes than the aggregate votes of remaining candidates, as the case may be.
- (8) Where at any ballot any of the three or more candidates obtain an equal number of votes and one of them has to be excluded from the election under sub-rule (7), the determination as between the candidates whose votes are equal of the candidate who is to be excluded, shall be by drawing of lots.

- (9) A nomination paper may be withdrawn by the candidate or the proposer before the Assembly meets on the day fixed for the election of the Deputy Speaker."
  - 3. Members are also informed that as sub-rule (2) of Rule 8, notices of motions for election of the Deputy Speaker will be received till 30:00 P.M. on Tuesday, the 20<sup>th</sup> June, 1978

# **ISSUE OF VISITOR'S CARDS**

The Speaker has directed that issue of Visitor's Cards for witnessing the proceedings of the House will be regulated as follows:

- (i) An application for a Visitor's Card shall contain the name of not more than one guest of a member.
- (ii) Application for Visitor's Card should reach the Assembly Section not later than 1:00 P.M. on the working day previous to the date for which the Visitor's Card is required.
- (iii) Not more than one Visitor's Card will ordinarily be issued to a member for a particular day.
- (iv) No Visitor's Card will ordinarily be issued on same-day application.
- (v) When Members apply for a Visitor's Card, they should ensure that the visitors are personally known to them.
- (vi) Applications for Visitor's Cards should be submitted on the prescribed form which may be obtained from the Assembly Section.
