PROPOSED AMENDMENT TO PRIVATE RESOLUTION

Under rule 128 of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, Pu K.Biakchungnunga, M.L.A has given notice of amendment to the resolution standing in the name of Pu c.Pahlira at serial No. 2, Bulletin Part II No. 156 dated October 20, 1982 as follows:-

"This Assembly is of the opinion that whereas, the status of Mizoram as a Union Territory for the last ten years does not bring peace and security any nearer;

And whereas, the promise of statehood during the peace talks between the Prime Minister and Mr. Laldenga also did not bring any political settlement for Mizoram.

Be it, therefore, resolved that as a measure of meeting the aspirations of the Mizo people and for bringing Mizoram at par with other tribals of the North Eastern Region, it is high time that the Government of India takes immediate steps to upgrade the Union territory of Mizoram to the status of a fully fledged State. And whom statehood is conferred it should be named ZORAM."
