1. Starred Questions

Starred Questions Nos. 9, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19 with supplementaries thereto were orally answered.

2. <u>Laying of Papers</u>

Pu Zairemthanga laid on the Table a copy each of the following:-

- (i) The Mizoram Animal (Control and Taxation) Rules, 1982.
- (ii) Mizoram Town (Sanitation) Rules, 1980 and
- (iii) Mizoram (Prevention and Control of Fire in the Village Ram) Rules, 1983.

3. Private Members' Bill

Under sub-rule (a) of rule 256 A of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly. Pu Sainghaka declined to move a motion to beg leave of the House to introduce a Bill amending the Mizoram Trading by non-Tribals (Regulation) (Amendment) Bill, 1983.

4. Private Members' Resolution

(i) Pu H.Rammawi moved the following resolution:-

"This Assembly is of the opinion that for the expeditions and more effective measures, the work of detection and deportation of the unauthorized foreigners from Mizoram which is now in the hands of the Army and BSF be entrusted to the Mizoram Police (MAP/MRP). Also, Mizoram Police Outposts be opened along the International Border at short intervals."

Again, he moved Amendment in the following form:-

"This Assembly is of the opinion that for the expeditious and more effective measures, the work of detection and deportation of the unauthorized foreigners from Mizoram be entrusted to Mizoram Police (MAP/MRP) and Mizoram Home Guards in addition to Army and BSF.

Also, Mizoram Police Outposts be opened along the international Border at short intervals.

And to speed up the work, foreigners Tribunal be constituted in each District in Mizoram with immediate effect."

Brig. Thenphunga Sailo, Chief Minister & Leader of the House replied to the debate. In course of his reply, the Chief Minister proposed amendment to be added at the end of the resolution as follows:-

"In view of the heavy load of administration shouldered by the Deputy Commissioner, the Tribunal by headed by the Additional Deputy Commissioner or Additional District Magistrate."

The motion was put to the Vote of the House and was passed in the following form:-

"This Assembly is of the opinion that for the expeditious and more effective measures, the work of detection and deportation of the unauthorized foreigners from Mizoram be entrusted to Mizoram Police (MAP/MRP) and Mizoram Home Guards in addition to Army and BSF.

Also, Mizoram Police Outposts be opened along the International Border at short intervals.

And to speed up the work, foreigners Tribunal be constituted in each District in Mizoram with immediate effect.

"This Assembly resolves that construction of Champhai-Minbung Road be started by the P.W.D. of the Government of Mizoram during this financial year."
