1. Obituary Reference:

Brig. Thenphunga Sailo, Chief Minister and Leader of the House made reference on the demise of Shri Kidar Pande, M.P.

Pu C.L.Ruala contributed to the reference.

The House stood in silence for one minute as a mark of respect of the departed soul.

2. Starred Questions:

Starred question Nos. 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39 and 40 with supplementaries thereto were orally answered.

3. Privilege Motion:

Pu K.Biakchungnunga raised a question of privilege against the Mizoram Congress (I) committee who has published a libel against Pu K.Biakchungnunga in the Booklet entitled to "Corruption Kawngkhar Vengtu" as having drawn a sum of Rs. 7,664.75 as T.A./D.A.

Brig. Thenphunga Sailo, laid on the Table a copy of the Report of One-man Inquiry Commission relating to Lakher District Council and Explanatory Memorandum thereon.

5. Presentation of Report:

Pu C.L.Ruala presented to the House the Ninth Report of the Committee on Government Assurances.

6. Official Resolution:

Brig. Thenphunga Sailo moved the following official resolution:-

"Whereas the jurisdiction of the Gauhati High Court extends to the Union Territory of Mizoram;

And whereas in view of the distance and lack of proper communication facilities, the people of Mizoram find it difficult to pursue cases in the High Court at Gauhati;

And whereas the salutary effect of cases being decided by the High Court is more or less denied to the people of Mizoram; And whereas in the public interest and in the interest of justice it is necessary to bring the High Court nearer to the people of Mizoram;

This House resolves to request the Government of India to take earl action for establishing Circuit Bench of the Gauhati High Court at Aizawl.

Pu Joe Ngurdawla spoke in favour of the Motion.

The motion was put to the vote of the House and was adopted unanimously.

7. <u>Bill introduced, considered and passed</u>

Pu Zairemthanga, Minister begged leave of the House to introduce the Bill amending the Mizo District (Administration of Town Committee) Act, 1955.

Leave having been granted by the House the Bill was introduced.

Pu Zairemthanga moved the Mizo District (Administration of Town Committee) Bill, 1983 be taken into consideration.

Pu Zairemthanga wound up the debate and moved that the Bill be passed.
