1. QUESTIONS

2. PRESENTATION OF REPORTS

- 1) Pu C.Vulluaia, Chairman, Committee on Estimates presented to the House

- 2) Pi L.Thanmawii presented to the House the Third Report of Committee of privileges.

3. PRIVATE MEMBER'S RESOLUTIONS

1) Pu L.Piandenga moved the following resolution:-

"This Assembly is of the opinion that the road from Saitual to Phaileng be made Truckable and the work of construction be taken up by BRTF or P.W.D. whichever is suitable.:

Pu J.Thankunga participated in the discussion.

The resolution was passed unanimously.

2) Pu H.Rammawi moved the following resolution:-

"This Assembly is of the opinion that Road construction work on the following roads be taken up by P.W.D.

- 1) Lungtian-Vartek-Darzo Ferry Road.
- 2) Vawmbuk-Archhuang-Thaltlang-Sangau Road
- 3) Lungpher-Phalhrang-Tuipui Ferry Road.
- 4) Sangau-Lungpuitlang-Muallianpui Road.

"This Assembly is of the opinion that cost of water connection to the residence of Hon'ble Members of the Assembly and the water charges thereto and also cost of electric connection to the residence of Hon'ble Members of the Assembly and the power consumption bill be borne by State Government with effect from April, 1979."

"This Assembly is of the opinion that Micro-Hydel Project on "Chelui" (Tlabung Point) be taken up by Government of Mizoram."
