RECOMMENDATION FOR MAKING DEMANDS FOR GRANT FOR 1979-80

The following communication dated the 16th August, 1979 has been received from the Lt. Governor (Administrator) of Mizoram:-

“I, N.P. Mathur, Lt. Governor (Administrator) of the Union Territory of Mizoram recommend for making Demand for Grants for 1979-80 in the Legislative Assembly of Mizoram for Rs. 71,23,55,000.00 (Rupees seventy one crores, twenty three lakhs and fifty five thousand) only inclusive of the sums specified in column 3 of the Schedule to the Mizoram Appropriation (Vote-on-Account) Act, 1979 (Central Act 13 of 1979) as per details given in the Annual Financial Statement, as required under Section 28 (3) of the Govt. of Union Territories Act, 1963 (Central Act 20 of 1963).”

RECOMMENDATION FOR LAYING SUPPLEMENTARY DEMANDS FOR 1973-74

The following communication dated the 16th August, 1979 has been received from the Lt. Governor (Administrator) of Mizoram:-

“I, N.P. Mathur, Lt. Governor (Administrator) of the Union Territory of Mizoram recommend for laying the Supplementary Demands for excess expenditure for 1973-74 before the Legislative Assembly of the Union Territory of Mizoram with the previous approval of the President of India as required under clause (b) of sub-section (1) of section 30 of the Union Territories Act, 1963 read with section 27 of the Act *ibid.*”

“I, N.P. Mathur, Lt. Governor (Administrator) of the Union Territory of Mizoram recommend for making of additional Demand for 1973-74 in the Legislative Assembly of Mizoram for Rs. 2,33,23,159.00 (Rupees two crores, thirty three lakhs, twenty three thousand, one hundred and fifty nine) only as detailed in the Supplementary Demands for grants of the Government of the Union Territory of Mizoram for 1973-74 as required under Section 28(3) of the Government of Union Territories Act, 1963.”
