1. Starred Questions

Starred Questions Nos. 5, 6, 9 and 10 with supplementaries thereto were orally answered. Starred Questions Nos. 7 and 8 listed for the day were not asked as the member in charge was absent.

2. Calling Attention

Under rule 57 of the Rules of Procedure and Conduct of Business in the Mizoram Legislative Assembly Pu L.Ngurdawla called the attention of the Minister in charge Home Department to the violent incidents which occurred on the 20th March, 1980 and on the 24th March, 1980 in different places in Mizoram to which Brig. T.Sailo, Chief Minister made a statement pertinent thereto.
