### 1. Starred Questions

## 2. Private Members' Business -Resolutions

(i) Discussion on the private member's resolution moved by C.L.Ruala on 13.3.1981 which was partly discussed continued.

Pu Bualhranga moved an amendment as follows-

"This House notes with grave concern the deteriorating condition of Pachhunga University College since it was handed over to the North Eastern Hills University.
