#### **BULLETIN PART I**

(Brief Record of Proceedings)

Friday, the 25<sup>th</sup> September, 1981.

## 1. Starred Questions

Starred Questions Nos. 5 to 15 with supplementaries thereto were orally answered.

#### 2. <u>Unstarred Questions</u>

Replies to Unstarred Question No. 1 was laid on the Table of the House.

#### 3. Motion

The Speaker informed the House that he has received a motion from Pu Lal Thanhawla, Leader of the Congress Legislature Party for an adjournment of the business of the Assembly for the purpose of discussing a matter relating to the current students agitation in Mizoram. The Speaker refused to give his consent on the ground that the matter is under adjudication by a Court of Law.

## 4. Private Members' Resolution

(i) Pu B.Lalchungnunga moved the following resolution.

"This Assembly is of the opinion that in view of day decrease in monetary value, the rate of compensation in respect of lands, houses, crops etc which was fixed some years ago becomes incompatible with the present monetary value. This House, therefore, resolves that the existing rate of compensation in respect of lands, houses, crops etc be revised immediately."

The following member took part in the discussion.

The motion was put to the vote of the House and was adopted.

(ii) Pu K. Lalsanga moved the following resolution-

"This Assembly is of the opinion that censorship be imposed on publication of books, Novels, Comics etc. published in the Mizo languages other than those books published by the Church Authorities."

He further moved an amendment as follows:-

"This Assembly is of the opinion that the Government should take effective steps for the prevention of publication of obscene literature in the Mizo languages, as such publications are against the best interest of the Mizo Community".

The mover wound up the discussion. The motion was put to the vote of the House and was adopted in an amended form.

"This Assembly is of the opinion that the Government of Mizoram feels it desirable to establish a Police Outpost at Cherhlun Grouping Centre which is situated at the Burma Border".

While winding up the debate the mover, with permission of the House, amended his resolution as follows:-

"This Assembly is of the opinion that the Government of Mizoram should take steps urgently to establish more police Outposts in Mizoram especially along the State as well as International Border".

The motion was put to the vote of the House.

The House adopted the resolution in an amended form.

(iv) Pu V.Lalnunzira moved the following resolution-

"This Assembly is of the opinion that REST HOUSE at Aizawl may be built purely for the protection of minorities' interest of Mizoram. Minorities group within Mizoram shall have the right to enjoy the REST HOUSE for the improvement of their physical needs.

e.g. Riang, Hrangkhawl, Sakachek".

He further move and amendment as follows-

"This Assembly is of the opinion that 'Khualbuk' (Rest House) be constructed at Aizawl purely for the benefits of visitors from the rural areas".

"This Assembly is of the opinion that 'Khualbuk' (Rest House) be constructed at Aizawl, Lunglei and Saiha purely for the benefits of visitors from rural areas".

(v) Pu J.Ngurdawla moved the following resolution-

"This Assembly is of the opinion that certain area of land be allotted for graveyards in all the protected area in Mizoram."

"This Assembly is of the opinion that the District Industries Centers in Mizoram be re-organised and established in all India Pattern as is done in other states".

The mover wound up the debate. The motion was amended by the mover was put to the vote of the House which was passed in an amended from as follows:-

"This Assembly is of the opinion that he District Industries Centers in Mizoram be re-organised and established in all India Pattern as far as practicable".

## (viii) Pu Bualhranga moved the following resolution:-

"This Assembly is of the opinion that Fire Control Act be made by the Government of Mizoram for protection of Agriculture Land from devastation by fire".

He further moved an amendment as follows:-

"This Assembly is of the opinion that Fire Control Rules be framed based on the Village Council Act, 1953 by the Government of Mizoram for protection of Jhum land from devastation by Fire".

The following member took part in the discussion:-

### (1) Pu Ellis Saidenga

The mover wound up the debate. The motion in an amended form was put to the vote of the House and was adopted.

(ix) Pu B.Lalchungnunga moved the following resolution-

"Whereas population in the Towns area is increasing rapidly; and whereas many families have been on the look-out for building for hire as they have neither land nor houses in the Towns;

And whereas many individuals have been holding permits for Agriculture land within the Town areas but not looking after them for the purpose for which the permits were granted;

Now, therefore, this House resolves that no permits for land holdings for Agriculture purposes within the Town the Town areas should be granted in future.

This House further resolves that permit for Agriculture land issued to individuals within Town areas but not utilized for the purpose for which they are granted be cancelled and allotted as house sites to Landless persons".
