KUM 2018-2019 FINANCE MINISTER BUDGET SPEECH

Pu Speaker,

1. I remtihnain kum 2018-19 atana Mizoram sawrkar sum hman tur ruahmanna, Budget Estimate leh kum kal mek 2017-18 atana Supplementary Demand te hi sawi ho a nih hnu a lungual taka min pawmpui turin ka rawn pharh dawn a ni.
2. He House zahawm taka ka tel thei leh chumi a zar a mipuite tana rawngbawlna hnathawk thei a ka awm hi vannei ka inti hle a. Sawrkar kum thar, 2018-19 State Budget pharh thei tura ka lo ding thei hi, Sawrkar leh Mizoram mipui te chungah lawm thu ka sawi tak meuh meuh a ni.
3. Hun kal tawhah he House zahawm tak Member ten Sawrkar Budget leh a kaihhnawih thil tam tak hi chik tak leh uluk takin an lo en țhin a. An ti takin an tui tih a hriat avangin Sawrkar aiawhin Member te chungah lawmthu ka sawi bawk a ni.
4. He sawrkar hnuaiah hian, Mizoram mipuite leh ramin hma a sawn theih nan hmalak chhoh mek zel a ni a. Ruahmanna thar țha tak tak kalpui mek a ni a. India ram State zinga State naupang ber pawl kan nih bakah, ram leilung hausakna tih tham kan neih loh avangin, kan neih chhun ang ang hmanga kan sum neih te pawh hi țangkai taka hman mek zel a ni.
5. Kan Chief Minister zahawm tak kaihhruaina leh remruatna hnuaiah kan ram sum leh pai dinhmun hian nasa takin hma a sawn a. Kan leiba leh kan GSDP khaikhinna debt-GSDP chu kum 2016-17 chhung khan 46.22% lo niin, kum 2017-18 ah phei chuan 40.87% ah

a lo tlahniam thei ta a. Kum 2018-19 chhunga kan sum mamawh phuhruk tura hmun dang aṭanga sum kan puk ngai zat tur pawh kan GSDP aṭanga chhutin, 1.14% chauh a lo ni ta a ni.

Budget Estimates
