PROGRAMME OF GOVERNOR ADDRESS TO ASSEMBLY ON 18TH 2003.

1. Members are informed that as provided in Rule 17(1) of the Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly, the Governor will address the Assembly on Tuesday, the 18th March, 2003 at 10:30 A.M.
2. Members are requested to be in their seats in the Assembly Hall by 10:25 A.M. on the 18th March, 2003.
3. On arrival at the Gate of Assembly House the Governor will be received by the Speaker and the Secretary of the Assembly. Thereafter, the Governor will be conducted to the Assembly Hall in procession in the following order:-

Assembly Marshal and ADC to Governor
Secretary
Governor and Speaker
Marshal will lead the procession and announce entry of His Excellency the Governor in the House.
4. All Members will rise in their seats as soon as the announcement is made. Then the M.A.P. Band Party will play the NATIONAL ANTHEM and the Members will resume their seats after the Governor has taken his seat.
5. The Governor will then address the House.
6. At the conclusion of the Address, the Governor will resume his seat for few seconds. The Governor again rises and National Anthem will be played by M.A.P. Band Party. Then the Governor leaves the House.
7. After the Governor has left, Members will resume their seats for transaction of Business of the House as per List of Business for the day.
