Tuesday, the 28th September, 1976

10:30 A.M.

1. Questions:

(a) Starred Questions: Starred Questions Nos. 121 and 123-130 with supplementaries thereto were orally answered. Starred Question No. 122 was not asked in the absence of the member to ask it. Question Nos. 121, 124 and 125 were answered by Pu Lalsangzuala, Minister i/c Supply & Transport Department on behalf of Pu H.Thansanga Minister i/c Education and P.W.D. All the Starred Questions listed for the day excepting question No. 122 were answered.

(b) Replies to Unstarred Questions, Nos. 14-17 were laid on the table.

2. Paper laid on the table: Pu P.B.Nikhuma, Deputy Minister, Local Administration laid on the Table of the House (a) The Order of the Lieutenant Governor (Administrator) dated 27th September, 1976 assuming to himself functions and powers vested in or exercised by the Chakma District Council under para 16(2) of the Sixth Schedule to the constitution, and (b) The Enquiry Report on the Chakma District Council Affairs.

3. Announcement: Pu Vaivenga, Speaker and Chairman of Rules Committee, announced that the Third Report of Rules Committee had been presented to the House on 21.9.1976, and since no proposal for amendment to the

Report was received during the period of 7 days, the Report stands approved.

4. Report of Business Advisory Committee: Pu Vaivenga, Speaker and Chairman, Business Advisory Committee, presented the Report of the Committee proposing extension of the Session by one day till 21.0.1976. The report was adopted by the House on a motion moved by Pu Lalsangzuala, Minister i/c Parliamentary Affairs.
5. Consideration and Passing of Government Bill: Pu Ch.Chhunga, Chief Minister i/c General Administration Department moved that the Societies Registration (Extension to Mizoram) Bill, 1976 be taken into consideration.
