iii) Such a decision may mitilate against All India Character of such services and may even affect National Integrity ; and

iv) On practical consideration, it seems that the decision is not necessary as even in the present system. The candidates are required to pass examination in language of these states to which they are allotted at the Academy and subsequently, in this state which is serving the purpose adequately. Now, therefore, this House do hereby resolved that the Government of India are to re-consider the decision immediately and correspond the arrangement which has been followed before the decision to introduce compulsory paper, on languages and medium of answer in the All India Services Examination". - Brig. Now, therefore, this House resolves to put an end to such so-called right of the man over a girl on the basis of Mizo customary law and practices and requests the Government to take all necessary steps to give effect to this resolution as early as practicable." - Pu F. Malsawma.

2. "Whereas, under the customary law applicable to the Mizo Society, the penalty for sexual offences leading to birth of illegitimate children is so meagre that it does not serve as a deterrent against such undesirable practices;

And, whereas, such a system under which young girls are duped into a situation leading to the birth of illegitimate children which effects not only such mothers and such children but also their relationship with different members in the family and affects family life which is the basic foundation on which the well being of a society is built upon;

And, whereas the well being of a society depends on the moral sense of the society;

And, whereas such practiceS are also alien to the religious belief of the Mizo society;

And, whereas there is now a great amount of public opinion against such indulgence in illegitimate relationship in the Mizo society;

Now, therefore, this House is of opinion that the Government should take all necessary steps, administrative as well as legal to put an end to such undesirable practices in the society. The steps taken by the Governmnet to give effect to this resolution be presented to the House for its consideration and adoption before enforcement". - Pu F. Malsawma.

"Whereas Mizoram under the erstwhile British Rule was kept outside the operation of normal law, except those which had been extended specifically by the Governor General or the Provincial Governor, as the case may be and was administered by separate Acts and Regulations such as the Bengal Eastern Frontier Regulations, 1873 (popularly called the Inner Line Regulation) and the Chin Hills Regulation, 1986 due to its distinctive peculiarities and problems and was declared totally excluded area under the government of India Act, 1935.

And whereas the said Regulations continue to remain in force in Mizoram by virtue of Article 372 of the Constitution and the Adoption orders issued under that Article;

And whereas the common feeling of the people of Mizoram on the issue had been reflected in part 8 of the Memorandum of Settlement between the Govt. of India and the Mizo National Front signed on 30th June, 1986, according to which the Inner Line Regulation as now in force in Mizoram will not be amended or repealed without consulting the State Government of Mizoram.

And whereas the Government of India is reported to contemplate revocation of the Inner Line Regulation and discontinue the system.

Now, therefore, this emergent Session of the State of Mizoram Legislative Assembly, having firm opinion that the continuance of the Inner Line Regulation in Mizoram is imperative not only for safeguarding the interests of the people, and for maintenance of peace and tranquility, but also for strengthening national integration, resolves that the Bengal Eastern Frontier Regulation, 1873 (V of 1873) as amended by the Bengal Eastern Frontier (Amendment) Regulation, 1925 (V of 1925) should continue to remain in force in Mizoram" - Pu J. Lalsangzuala, Minister.

WHEREAS it has been established that consumption of Tobacco is a major health hazard which causes various types of cancer, cardio-vascular and respiratory diseases and other similar ailments;

AND WHEREAS out of the estimated three million tobacco-related deaths in the world today, about 0.8 million deaths take place in India;

AND WHEREAS this major health problem can be prevented if consumption of tobacco-related products are reduced;

AND WHEREAS there is at present no comprehensive and uniform legislation throughout India discouraging the use of tobacco and tobacco products, in any form, providing for complete ban on all forms of advertisements in respect of tobacco-related products, banning of tobacco smoking in public places, printing of statutory warning in the form of slogans on all packages of tobacco and tobacco products, ban on the sale of tobacco or tobacco products within specified distances from educational, medical and other institutions and for all matter connected therewith or ancillary and incidental thereto;

AND WHEREAS it is necessary to enact a comprehensive law providing for all matters referred to in the above paragraph;

AND WHEREAS the subject matter of such a law, except cigarette which is relatable to entry 33, list III-concurrent of the Seventh schedule to the Consitution of India, is relatable to entries 6 and 26 of the II - State List of the Seventh Schedule to the Constitution of India and Parliament has no power to make laws for the States with respect to the aforesaid matters except as provided in articles 249 and 250 of the Constitution of India;

AND WHEREAS it appears to this Legislative Assembly to be desirable that the aforesaid matters should be regulated in the states of Mizoram by Parliament by law;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of article 252 of the Constitution of India, this House hereby resolves that a comprehensive and uniform legislation to discourage the use of tobacco and tobacco products, in any form, providing for complete ban on all forms of advertisements in respect of tobacco related products, banning of tobacco smoking in public places, printing of statutory warning in the form of slogans on all packages of tobacco and tobacco products, ban on the sale of tobacco or tobacco products within specified distances from educational, medical and other institutions, and all matters connected therewith or ancillary and incidental thereto should be regulated in the State of MIZORAM by Parliament by law. - Pu C. Chawngkunga, Minister.
