No. A. 12018/25/80—APT(B), the 27th. January, 1982. In exercise of the powers conferred by the proviso to Article 309 of the constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/21/71—HMJ(ii) dated 21st January, 1972 and all other powers enabling him in this behalf, the Administrator of Mizoram hereby makes the following rules to further amend the Mizoram Jails Department (Group 'B' posts) Recruitment Rules, 1979 issued under Notification No. HMJ. 23/73/34—37 dt. 11.7.79, namely:—

- 1. (1) These rules may be called the Mizoram Jails Department (Group 'B' post) Recruitment First Amendment Rules, 1981.
  - (2) They shall come into force on the date of their publication in the official gazetie.
- In the Mizoram Jails Department (Group 'B' post) Recruitment Rules, 1978, in the schedule under column 10 and 11, the following clause shall be substituted:
   50% promotion and 50% for Civil Service officer in the scale of Rs. 550-900/- failing

which by transfer on deputation.

Promotion: 50% from Jailer with 3 years experience with training passed under the Jails administration / correctional services in the grade.

Transfer on deputation: Officers from Central or State Govts. or U. Ts. Administration holding analogous posts.

### D. FUNCTIONS OF THE COMMITTEE

(1) To prepare annual and Five Year Plan in relation to the need of the District Council area.

(2) To review the Progress of various development schemes implemented by the different department within the District Council area from time to time, and submit a quarterly report to the Deputy Commissioner.

(3) To advise on Integrated implementation of plans, utilisation of funds allotted and to suggest priorities

for expenditure within the sum allotted by the Government.

(4) To promote public participation and cooperation in development Programmes and expand local community.

- (5) To help allocation and Preparation of Schemes for utilisation of grant made available for various developmental works under Plan and Non-Plan and Centrally Sponsored Programme.
- E. The Committee should meet frequent to discuss various development matters for implementations of the Plan Schemes, to watch the Progress and to remove any deficiencies noticed during a particular period.
- It. The preceeding of the meeting of the Committee should be forwarded to the Deputy Commissioner and to the Development Commissioners/Secretary, District Council.
