No. A.12018/18/80-APT(B), the 5th Feb 82. In exercise of the powers conferred by the provise to Article 309 of the Constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT-(ii) dated the 21st. Junuary 1972 and all other powers enabling him in this behalf the Administrator of Miszoram is pleased to make the following rules relating to the recruitment to the posts of Sub-Treasury Officer under Accounts & Treasuries Department, Govt. of Mizoram, namely :-

- 1. Short title and ' Commencement
- : 1) These rules may be called the Mizoram Accounts & Treasurles Deptt. (Group 'B' posts) Recruitment. Rules, 1981.
- 2) They shall come into force on the date of their publication in the Official Gazette.

2. Application These Rules shall apply to the posts specified in Column 1 of the Schedule hereto annexed.

3. Number of posts: The number of the said posts, their classification and classification and the scales of pay attached thereto shall be as specified in Columns 2 to 4 of the Scheduled aforesaid.

Method of rectt.: The age limit, qualifications and other matters relating to age limit and the said posts shall be as specified in Columns 5 to 13 •ther qualification of the said Scheduled

Provided that the upper age limit prescribed for eirect rectt. may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other Special categories of persons in accordance with the orders issued by the Central Govt. of Govt. of Mizoram from time to time.

Disqualification : No person :

a) Who has entered into or contracted a marriage with a person having a spouse living.

b) Who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

that the Administrator may, Provided if satisfied that such marriage is permissible und, the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

Training and ń. Departmental Examination.

Every Govt. servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.

7. Power to relax

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8. Reservation other: concessions

Nothing in these rules shall effect reservation and other concessions required to be provided for the scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt, or Govt, of Mizoram from time to time in this regard.

9. Repeal and saving:
