ORDERS BY THE LT. GOVERNOR (ADMINISTRATOR)

NOTIFICATION

No. A. 12018/58/80-APT(B), the 25th July, 1982. In exercise of the powers conferred by the proviso to Article 309 of the constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21st January, 1972 and of all other powers enabling him in this behalf, the Administrator of Mizoram hereby makes the following rules further to amend the Mizoram Supply & Transport Department (Class-111 posts) (C.T.C) Recruitment Rules, 1974 issued under Notification No. STE. 17 (A)/75/ dt. 18.7.1975, namely : —

1. (1) These rules may be called the Mizoram Supply & Transport Department (Group C, posts, C.T.C) Recruitment First Amendment Rules, 1982.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Schedule of the Mizoram Supply & Transport Department (Class 111 posts-C.T.C.) Recruitment Rules, 1974 (hereinafter referred to as the said Rules) under Column 3, the classification of post in respect of conductor, viz. Class 111 (Non Gazetted), for the words "Class 111" the words "Group 'C'" shall be substituted.
3. In the schedule of the said Rules under Column 4 for the scale of pay Rs. 110 3-125-EB-3-140-EB-3-149-EB-4-165 the scale of pay Rs. 260-6-290-EB-6-326-8-350 shall be substituted.

4. In the schedule of the said rules, under column 6,
i) the words "Age limit is relaxable by 5 years in case of candidates belonging to scheduled Castes/Scheduled Tribes" shall be Omitted.
ii) the words "sea foot notes -
Foot Notes : The crucial date for determining age limit mentioned in Col. 6 of the Recruitment Rules will, in each case be the closing date for receipt of applications from candidates in India (Other than Andaman & Nicobar Islands and Lakshadweep).
- In respect of posts, the appointment to which are made through the Employment Exchanges, the crucial date for determining age limit will, in each case, be the last date upto which the Employment Exchanges are asked to submit the names" shall be added.
5. In the schedule of the said rules, under Col. 7, the words "First Aid Certificate" shall be substituted by the words "Conductor's Licence".
6. In the schedule of the said rules, under Col. 10, for the existing entries "Direct recruitment" the words "70% by direct recruitment and 30% by promotion" shall be substituted.
7. In the schedule of the said rules under Col. 11, for the existing entries "Not applicable" the words "**PROMOTION** from Handyman of the Department in the scale of Rs. 196-3-220-EB-3-232/-p.m. having not less than 5 years services in the grade" shall be substituted.
