5. Disqualification

No person.

- a) Who has entered into or contracted a marriage with a person having a spouse living,
- b) Who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rules.

6. Training and Departmental Examination

Every Govt. servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.

7. Power to relax

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8. Reservation other concessions

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.

9. Repeal and Saving

All Rules pertaining to these posts, framed by the Governor of Assam and were in force in the ertswhile Mizo District and continued to be in existence in persuance of Govt. of India Ministry of Home Affairs Notification No. 14/21/17-HMT(ii) dt. 21.1. 1972 are hereby repealed.

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
