#### NOTIFICATION

No. A. 12018/59/80-APT (B) the 3rd September, 1981. In exercise of the powers conferred by the proviso to Article 309 of the constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dated 21st January, 1972 and of all other powers enabling him in this behalf, the Administrator of Mizoram hereby makes the following rules further to amend the Mizoram Jail Department (Group 'C' posts) Recruitment Rules, 1977 under Notification No. HMJ 22/73/pt. 1 dt. 9.10.1978, namely:—

1. (1) These rules may be called the Mizoram Jail Department (Group 'C' post) Recruitment First Amendment Rules, 1982.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the schedule under Col. 10 of the Mizoram Jail Department (Group 'C' post) Recruitment Rules, 1977, for the existing entries in respect of the post of Jailor, the following shall be substituted:—

“100% Promotion, failing which by direct recruitment/transfer on deputation,”
