Governor (Administrator) of the Union Territory of Mizoram is pleased to make the following rules to amend the Salaries and Allowances of Minister, Mizoram (Grant of Motor Car Advance) Rules, 1974 namely :-

Short title and commencement. (1) These Rules may be called the Salaries and Allowances of Ministers, Mizoram (Grant of Motor Car Advance) Amendment Rules, 1982.

(2) They shall come into force at once.

Amendment of Rule 3. 2. In clause (a) of rule 3 of the Salaries and Allowances of Ministers, Mizoram (Grant of Motor Car Advance) Rules, 1974, for the figures, brackets and words "33,000 (thirty three thousand)" the letters, figures, brackets and words " Rs 15000/ (Rupees fifteen thousand)" shall be substituted.
