#### **NOTIFICATIONS**

No. DCA/R-55/82/9, the 29th September, 1982. In exercise of the powers conferred by sub paragraph (6) of paragraph 2 of the Sixth Schedule to the Constitution of India, the Lt. Governor (Administrator) of the Union territory of Mizoram is pleased to make the following rules further to amend the Mizoram District Councils (Constitution and Conduct of Business of the District Councils) Rules' 1974, namely:—

Short title and commencement.

Amendment in the Rules.

- 1. (1) These rules may be called the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Amendment Rules, 1982.
  - (2) They shall come into force at once.
- 2. In the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, for Appendix IV, the following shall be substituted, namely:—

Governor (Administrator) of the Union territory of Mizoram is pleased to appoint with respect to the said election:—

- (a) 3 pm on 15th October, 1982 as the last date for making nominations.
- (b) 3 pm on 15th October, 1982 as the date for scruting of nominations.
- (c) 16th October, 1982 as the date on which scrutiny of nominations may continue, if necessary.
- (d) 6th November, 1982 as the date on which poll shall, if necessary, be taken; and
- (e) 15th November, 1982 as the date before which the elections shall be completed.

Now, therefore, in exercise of the powers conferred by sub-rule (2) of rule 125 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of the Union territory of Mizoram is pleased to call upon every constituency in the said Autonomous District to elect a member in accordance with the provision of the said rules before 15th November, 1982.
