ANNEXURE

BOUNDARY OF LUNGLAWN II VILLAGE COUNCIL.

The boundary starts at "Lungtohlawt" obove Pu Thangchema's house, and taking Pu Thangchema's house into Lunglawn II area, it follows a nulla upto Aizawl— Lunglei Road. Crossing the road it catches a Jeep Road near Pu Rothuama's house, and follows the Jeep road till it meets a source of Aikhalui stream. It follows the stream downwards and meets Nghasih stream. Following Nghasih stream til the confluence of Sipailui, it catches-up Sipailui, and follows it upwards. From Sipailui, the boundary catches another stream cailed, "Farinveng Tuikhur lui" and follows it upwards, and then catches Falkawn Tuikhur stream and follows it upto Falkawn. At Falkawn it crosses Main Road just comprising of Pu Chalsela's house and goes downwards along a nulla and meets Tlabung Road. Following the road towards the south the boundary catches a nulla below "Lungtohlawt" and follows it upwards, till it reaches "Lungtohlawt" which is the starting point.
