No. L-19013/6/82-POL(C), the 29th October, 1982. Whereas the members of the so called Mizo National Front and Mizo National Army are engaged in the commission of offences pre-judicially affecting the public safety and maintenance of public order ;

And, whereas, the inhabitants of Phaileng village under Pangzawl Group Centre in Lunglei District have been abetting the commission of such offences by harbouring and rendering assistance to the aforesaid persons concerned in the commission of such offences and have failed to render all assistance in their power to discover or apprehend the aforesaid offenders;

Now, therefore, the Lt. Governor (Administrator) of the Union territory of Mizoram, in exercise of powers conferred by section 7 of the Assam Maintenance of Public Order (Autonomous District) Act, 1953 (Assam Act XVI of 1953), is pleased to impose a collective fine of Rs 3500/- on the inhabitants of the said Phaileng village under Pangzawl Group Centre to be realised in the manner specified in the said section by the District Magistrate, Lunglei.
