No. DCA/E-187/82/19, the 2nd November, 1982. Whereas a general Election has to be held for the purpose of constituting a new District Council for Chakma Autonomous District;

Now, therefore, in exercise of the powers conferred by sub-rule (2) of rule 125 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to call upon every Constituency in the said Autonomous District to elect a member in accordance with the provisions of the said rules before the 20th December, 1982.

No. DCA/E-164/82/Part/91-92, the 11th Nov., 1982. In exercise of the powers conferred by sub-rule (1) of rule 33 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to fix 11 A.M. on the 17th Nov. 1982 as the date for the holding of the election of the Chairman of the Pawi District Council.

No. DCA/E-187/82/34, the 17th November, 1982. In exercise of the powers conferred by sub-rule (1) of the rule 141 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to fix the hour from 7:30 AM to 4:00 PM as the hours during which the poll shall, if necessary, be taken at the election to the Chakma Autonomous District Council to be held in pursuance of Notification No. DCA/E-187/82/20 dt 2nd November, 1982 published in Mizoram Gazette Extra - ordinary on 2nd November, 1982.

No. DCA/E-164/82/188, the 16th Nov., 1982. In exercise of the powers conferred by the proviso to sub-rule (2) of rule 22 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974,

- (d) 7th December, 1982 as the date on which Poll shall, if necessary, be taken; and
- (e) 20th December, 1982 as the date before which the elections shall be completed.
