No. SC/Coffee/77-80/256, the 7th January, 1983. In exercise of the powers conferred by section 15 of the Coffee Act, 1942 (Central Act VII of 1942,) the Lt. Governor (Administrator) of the Union Territory of Mizoram is pleased to make the following rules, namely:

- Short title
- (1) These rules may be called the Mizoram Coffee Estates and extent : Owners' Registration Rules, 1982.
 - (2) They extend to the whole of the Union territory of Mizoram.
- Definitions

In these rules, unless the context otherwise requires-

- "Act" means Coffee Act, 1942 (Central Act, VII of 1942)
- (ii) "Form" means a Form appended to these rules;
- (iii) "Government" means the Government of Mizoram;
- (iv) "Registering Officer" means the Registering appointed by the Government under sub-section (1) of section 14 of the Act within whose jurisdiction the whole or any part of the estate is situated.
- Application for Application for registration under section 14 of the Act shall be registration: made to the Registering Officer in duplicate in Form 'A' for each estate by the applicant.
- Certificate of If an application for registration is granted the Registering registration: Officer shall issue a certificate of registration in Form 'B'
- Application for (1) cancellation .
 - An application for concellation under section 14 of the Act shall be made to the Registering Officer in duplicate in Form 'C'
 - (2) Every application under sub-rule (1) shall be accompanied by a fee of two rupees.
 - (3) If an application for cancellation of registration is granted, the registering Officer shall issue a certificate in Form 'D'.

6. Transfer

: A registered owner shall, in the event of any of his estate being sold or otherwise transferred, intimate to the Registering Officer within one week of such sale or transfer, particulars of the estate sold or transferred and the postal address of the persons to whom it was sold or transferred.

7. Notice to coffee Board

The Registering Officer shall not issue a certificate of cancellation of registration in respect of any estate without giving advance notice of not less than one month to the Indian Coffee Board of his intention to do so.

8. Registers

The Registering Officer shall maintain a register of registered owners in Form 'E' and register of registered estates in form 'F' shall forward to the Board from time to time certified copy of all entries in this registers and a copy of every certificate of cancellation in Form 'D' which he has issued. He shall also forward to the Board duplicate copy of every application in Form 'A' when the application is granted.

9. Board's powers:

The Board may, if they consider necessary to secure compliance with the provisions of these rules, depute and the records maintained by any registered owner.

10 Eligibility for registration

Any persons who owns not less than one hectare (i.e. 2,000 to 2,500 plants) will be eligible for registration under these rules.
