Attack Market

No. DCA/E-176/82/205(A), the 26th March, 1983, Whereas by notification No. DCA/E-176/82/178 dt. 9.2.1983, the Lt. Governor (Administrator) of the Union Territory of Mizoram has assumed to himself all the functions and powers vested in, or exercisable by, the Lakher District Council with effect from 10.2.1983 and the said functions and powers are declared to be exercised by the D.C., Chhimtuipui District Saiha or by an Officer or Officers as may be nominated by the Administrator;

And whereas by notification No. DCA/E-176/82/180 dt. 17.2.1983, the SDO (Sadar), Saiha has been nominated as the Officer to look after the works of the Lakher District Council as Special Officer under the over all supervision of the D.C. Chhimtuipui District, Saiha.

And whereas, the Lt. Governor (Administrator) of Mizoram is satisfied that circumstances exist for appointing a Commission to examine and report on certain matters relating to the further course of action to be taken in relation to the Lakher District Council;

Now, therefore, in exercise of the powers conferred by sub-paragraph (1) of paragraph 14 of the Sixth Schedule to the Constitution of India, the Lt. Governor (Administrator) of Mizoram is pleased to appoint a one man Inquiry Commission consisting of Shri D.M. Spolia, I.A.S., Deputy Commissioner, Langlei, to inquire and submit its report to the Lt. Governor (Administrator) within 20 days from the date of receipt of this order on the terms of reference given below.

The Commission shall follow the normal procedures of Inquiry including examination of witnesses and acceptance and consideration of such memoranda or representations as may be submitted by any person or persons. In other respects the Commission is free to evelve and follow its own procedure.

The terms of reference to the Commission are as follows:-

- (a) whether the existing arrangement mentioned above is conducive to proper administration of the Lakher District Council;
- (b) whether in the present circumstances, there is scope for formation of an Executive Committee, or whether the dissolution of the District Council is called for;
- (c) any other matter relevant under the circumstances and considered necessary in the interest of administration of the Lakher District Council.

In exercise of the powers conferred by the provisio to Article 309 of the constitution read with the Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21st January, 1972 the all other powers enabling him in this behalf, the Administrator of Mizoram is pleased to make the following rules further to amend the Mizoram Education & Social Welfare Deptt. (Group 'B' posts) Recruitment Rules 1981 published in the official Gazette dt. 18.1.1982 under Notification No. A. 12018/23/80-APT(8) dated the 15th January, 1982 namely:-

- 1. (1) These rules may be called the Mizoram Education & S.W. Department (Group 'B' posts) Recruitment First Amendment Rules, 1982.
 - (2) They shall come into force on the date of their publication in the official Gazette.
- 2. In the Schedule under column 11 of the Mizoram Education & S.W. Department (Group 'B' posts) Recruitment Rules, 1981 in respect of the post of Vice-Pincipal, Teachers Training Institute, the existing entries shall be substituted as under-"PROMOTION": 50% from Senior Instructors/Instructors of Teachers Training Institute with not less than 5/7 years experience in the grade, subject to suitability and eligibility.

50% from Asstt. Headmasters/Head Mistress of Govt. High School, Post Graduate Teacher in Govt. High Schools & Multipurpose Schools, Head Mistress of Govt. Model School with not less than 5 yrs experience in the grade, subject to suitability and eligibility.

TRANSFER ON DEPUTATION: Officers holding equivalent posts in Education Department of Govt. of Mizoram/other States Govts. (Period of deputation ordinarily not exceeding three years.)
