No.429/MIZ/83(1) :- In exercise of the powers conferred by sub-section (1) of section 13C of the Representation of the People Act, 1950, the Election Commission hereby direct that the following further amendment shall be made in its notification No.429/MIZ/75(1) dated the 17th May, 1975, namely :-

In column 2 of the Table appended to the said notification,

- (viii) for the existing entry against item 8, the entry "Block Development Officer, Lunglei" shall be substituted
- (ix) for the existing entry against item 10, the entry "Block Development Officer, Lunglei (E)." shall be substituted ;
- (x) for the existing entry against item 16, the entry "Additional Block Development Officer, Phullen " shall be substituted ;
- (xi) for the existing entry against item 27, the entry "Assistant to Deputy Commissioner (P), Aizawl " shall be substituted ;
- (xii) for the existing entry against item 29, the entry "Assistant to Deputy Commissioner, (Revenue) Aizawl" shall be substituted ; and
- (xiii) for the existing entry against item 30, the entry "Circle Officer (LAD) Aizawl " shall be substituted.

O B I T U A R Y

The Government of Mizoram have learnt with deep sorrow the sudden and premature death of Shri Lalbiakthanga, Superintendent, Vigilance Department by an accident while he was returning home after duty on 31st March, 1983 at Aizawl at about 7.30 P.M.

Shri Lalbiakthanga, born on 18th December, 1952, entered in the Government service in Deputy Commissioner's Office, Aizawl on 10th March, 1972. He was transferred to the Secretariat on 1st February, 1973 as a special case in view of his qualities. He was promoted to the post of Superintendent on 19th April, 1982 as a result of Competitive Examination and posted in Vigilance Department till his death. He was trained in Administrative Vigilance Course in Delhi. Shri Lalbiakthanga is survived by his wife and four Children.

Shri Lalbiakthanga endeared himself to the Officers and staff and always provided himself a conscientious Officer.

The Government of Mizoram place on record their appreciation of the sincere services rendered by Shri Lalbiakthanga and convey heartfelt sympathy to the bereaved family.
