NOTIFICATION

S.O.— Whereas the Election Commission, in pursuance of the provisions of paragraph 6 read with paragraph 7 of the Election Symbols (Reservation and Allotment) order, 1968, is satisfied that as satisfied that as a result of its poll performance at general election to the Legislative Assembly of Tripura State held in January, 1983, the Revolution Socialist Party is entitled for recognition as a State Party in the State of Tripura in terms of para 6 of the said Order.

AND whereas the Commission has decided to recognise the Revolutionary Socialist Party in Tripura State as a State Party;

- Now, therefore, in pursuance of clauses (b) and (d) of Sub-paragraph (1) and Sub-paragraph (2) of paragraph 17 of the said symbols Order, the Election Commission hereby makes the following amendments in its notification No. 58/82, dated the 8th April 1982, published as O. N. 29 (E), in the Gazette of India Extra-ordinary part II, Section 3 (iii), dated the 12th April, 1982, as amended from time to time, namely:—

 - "1. Revolutionary Socialist Party Spade and Stocker.
 - 2. Tripura Upajati Juba Samit Two leaves"
- 2. In Table 4 of the said notification, against item 20. Tripura in column 1 the entry "11. Spade and Stocker" under column 2 shall be deleted and the existing entries 12 and 13 shall be remembered as 11 & 12, respectively;

The recognition granted to the above-mentioned political party is subject to the following conditions:-

- (i) The party shall communicate to the Commission without delay and change in its name, head office, office beavers address and political principles, policies, aims and objectives and any change in any other material matters;
- (ii) The Party shall intimate the Commission immediately whenever any amendments are issued to Party constitution along with the relevant documents like the notice for the meeting to consider amendment agenda for the meeting, minutes of the meeting where the amendments have been carried etc:
- (iii) The party shall maintain all the records like minutes books, accounts books, membership registers, receipt books etc. properly.
- (iv) The said records shall be open for inspection at any time by the authorised representative(s) of the Commission; and
- (v) The recognition granted shall be reviewed by the Commission from time to time.
