NOTIFICATION

S. O.— Whereas the Election Commission of India has, by its notification No. 56/82—VI, dated the 1st December, 1982, accorded adhoc recognition to Indian Congress (J), as a State Party in the State of Haryana in terms of para 6 of the Election Symbols (Reservation and Allotment) Order, 1968, on the basis of provisional information regarding general Election held in the State held in 1982 made available ;

And whereas the adhoc recognition granted was made subject to review of the poll performance of that party on receipt of final figures in respect of the relevant General Election ;

And whereas the Election Commission is satisfied on the basis of the information now available in its possession that the Indian Congress (J) is entitled for registration and recognition on the basis of its poll performance during the general election to the Haryana Legislative Assembly held in May, 1982 ;

Now, therefore, in pursuance of clause (b) of sub para (1) and sub para (2) of paragraph 17 and paragraph 18 of the said symbols Order the Election Commission hereby directs that the Indian Congress (J) shall be a State Party in the State of Haryana under para 6 of the said Symbols Order, with the Election Symbols (Scales) reserved for it.

The recognition granted is subject to the following conditions: ---

- (i) The party shall communicate to the Commission without delay and change in its name, head office—bearers and addresses or political principles, policies, aims and objectives and any change in any other material matters;
- (ii) The party shall intimate the Commission immediately whenever any amendments are issued to party constitution along with the relevant documents like the notice for the meeting to consider amendments, agenda for the meeting, minutes of the meeting where the amendments have been carried out, etc.
- (iii) The party shall maintain all the records like minute Book, account books, membership registers, receipt books, etc. properly.
- (iv) The said records shall be open for inspection at any time by the authorised representative(s) of the Commission; and
- (v) The recognition granted shall be reviewed by the Commission from time to time.
