## NOTIFICATION

No. B. 13016/10/92-EDN (A), the 12th November, 1992. Whereas the Government deems it expedient to provide financial assistance to the Scheduled Tribe students or trainees undergoing two years' course of the Pre-Service Teachers Education, the Governor of Mizoram is pleased to make the following rules, namely :-

### 1. SHORT TITLE AND COMMENCEMENT :

- (a) These Rules may be called the Mizoram (Award of Stipend to Pre-Service trainees in the Diploma of Teachers Education) Rules, 1992.
- (b) They shall be deemed to have come into force with effect from the 1st February, 1992.

### 2. DEFINITIONS :

In these Rules, unless the context otherwise requires-

- (a) 'Department' means the Education & Human Resources Department ;
- (b) 'Director' means the Director of School Education ;
- (c) 'Government' means the Government of the State of Mizoram ;
- (d) 'Stipend' means such financial assistance given to the trainees under these rules ;
- (e) 'Student' means trainees in the Institute ;



### 3. SANCTION OF STIPEND :

The State Government shall sanction in every academic year such amount of financial assistance mentioned in rule 5 to the deserving students or trainees in the District Institute of Education & Training.

### 4. ELIGIBILITY :

The following persons shall be eligible to receive the financial assistance referred to in rule 3, if -

- (a) he/she is a permanent resident of the State of Mizoram belonging to Scheduled Tribe having a certificate thereof from the competent authority ;
- (b) he or she is regular in studies and attendance ;
- (c) he or she is awarded any scholarship or stipend ;
- (d) he or she is not a repeater at any stage of the course ;
- (e) he/she is not employed in any capacity under the Government.

### 5. AMOUNT OF STIPEND :

(1) The amount of stipend will be admissible at the rate as indicated below :

- (a) Stipend : Rs. 350/-p.m. for ten months of academic session in a year ;
- (b) Book grant : Rs. 500/- per session.

(2) A student receiving book grant from the Government should utilise the book grant for which it is sanctioned.

### 6. MODE OF APPLICATION :

Application for the stipend shall be submitted in the prescribed form as per Annexure-A to these Rules to the Director through the Institute where the candidate is pursuing his/her studies within the date fixed by the Director.

### 7. SANCTIONING AUTHORITY :

The Director will sanction the stipend on the basis of the recommendation of the Head of Institute subject to the provisions under rules 4 and 5.

### 8. MODE OF PAYMENT :

The stipend shall be paid to the trainees through the Institutions in which the trainees pursue their studies.



## 9. CANCELLATION AND WITHHOLDING OF STIPEND :

A stipend may be cancelled or withheld by the sanctioning authority for a particular period—

- (a) if a trainee has failed in an annual examination or if the progress/conduct of the trainee continues to be unsatisfactory ;
- (b) if a trainee is furnishing false statement suppressing material facts.

## 10. MISCELLANEOUS PROVISION :

- (1) If any question arises relating to the interpretation of these Rules, it shall be referred to the Government and the decision of the Government shall be final.
- (2) The Government may amend or modify any provision of these rules at any time as it consider necessary.
