NOTIFICATION

No.H. 12018/9/91-LJD/pt, the 4th March, 1993. The following Act of the Mizoram Legislative Assembly which received the assent of the Governor is hereby published for general information.

The Mizoram Act No. 3 of 1993

The Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly (Amendment) Act, 1993

(Received the assent of the Governor of Mizoram on the 1st March, 1993)

AN ACT

further to amend the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly Act, 1987.

Be it enacted by the Legislative Assembly of Mizoram in the Forty-Fourth Year of the Republic of India as follows, namely :—

Short title and
commencement.

1. (1) This Act may be called the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly (Amendment) Act, 1993.
- (2) It shall come into force from the date of its publication in the Official Gazette.

Amendment of
section 2.

2. In the Mizoram Salaries, Allowances and Pension of the Members of the Legislative Assembly Act, 1987 as amended from time to time (hereinafter referred to as the principal Act), in section 2, in clause (h), in line 9 to 14, for the words "such other business and includes, except in the case of Member who ordinarily resides at the place where a session of the Assembly or a sitting of the committee is held or where any other business connected with his duties as such Member is transacted", the words "SUCH OTHER BUSINESS IS TRANSACTED AND INCLUDES" shall be substituted.

Amendment of
section 3A.

3. In the principal Act, in section 3A,—
 - (i) in line 4, between the words "as a Member" and the words "for a period of ", the word "and" shall be inserted;
 - (ii) in line 7 to 9, for the words "he shall be entitled to a residence for which rental charges shall be not more than three thousand rupees per mensem", the words "he shall be entitled to a residence for which rental charges of not more than three thousand rupees per mensem" shall be substituted.

Amendment of
section 4B.

4. In the principal Act, in section 4B, in clause (b), for the word "or", the word "and" shall be substituted.

Insertion of
new proviso.

5. In the principal Act, in section 12, after clause (b) of sub-section (1), a new proviso shall be added, namely :—

"Provided that a member who has taken a loan or an advance under section 12(1) (a) and section 12(1) (b) respectively is not allowed to take a fresh loan or advance, as the case maybe, unless and until he/she has repaid the loan or the advance taken during the previous term with interest thereon".

Amendment of
section 14.

6. In the principal Act, in section 14, (5), the following new sub-section shall be inserted as follows namely :—

"(6) Notwithstanding anything contained in this Act in respect of pension, where any person, entitled to any pension with respect to his rendering Military Service, later becomes a Member, he is also entitled to a pension under this Act.

EXPLANATION - A Member is entitled to both Military pension and the pension under section 14 of this Act. This Amendment shall be deemed to have been effective from the date of the commencement of the principal Act".
