Lungdar and (bifurcated from Khawzawl Soil & Water Conservation Divn.) and newly created Thenzawl Soil & Water Conservation Range.

The Headquarters of Serchhip Soil & Water Conservation Divn. will be at Serchhip and the Headquarters of four Ranges above will be at Serchhip, F. Lungdar, S.Khawbung and Thenzawl respectively. The boundary description of this newly created Divn&Serchhip &Thenzawl Ranges will be as per Annexure 'A' B' & 'C'.

BOUNDARY DESCRIPTION OF SERCHHIP SOIL&WATER-CONSERVATION DIVISION

> Headquarter Area

: Serchhip : 1971Km.sq. (Approx)

GEOGRAPHICAL POSITION: It lies between 92° 37' to 93. 27' East Longitude and 23°.1' to 23° 33' North Latitude.

Boundary Details ;1. Northern Side:—The boundary line starts from the confluence of River Tlawng and Changte in the north western corner near Lungsei Village. It then follows river Changte in South Eastern direction then it meets river Mawngping. Then the boundary turn in northerly direction upto the stream

side of river Tuirial near Zobawk Village and then it follows along the Inter-Block Administrative boundary line of Serchhip and Thingsulthliah Block upto the confluence of river Tuivawl and Arthladawnlui. It then follows along with the Inter-Block Administrative boundary line of Serchhip and Khawzawl and then it follows again along with the Inter-Block Administrative boundary line of Khawzawl and East Lungdar upto the Inter-national boundary line of Burma and India.

- 2. EASTERN SIDE: It-then turns towards Southerly circution by following the International Boundary line of Burma and India upto the confluence of Tiau and Buhtunlui.
- 3. SOUTHERN SIDE: The Boundary line then turns towards westerly direction by following the Inter-District boundary line of Aizawi and Lunglei till it meets river Tlawng near Sertlangpui Village.
- 4. WESTERN SIDE: Lastly, the boundary line follows along with the Tlawng river in Northerly direction till it meets the starting point.

Serchhip Soil & Water Conservation Division consists of the following Ranges.

- 1. Serchhip Range.
- 2. Thenzawl Range.
- 3. E. Lungdar Range.
- 4. S. Khawbung Range

BOUNDARY DESCRIPTION OF THE PROPOSED THENZAWL SOIL & WATER CONSERVATION (Under Serchhip S&WC RANGE Div).

Headquarter - Thenzayl
Area - 435.00 (Approx).

GEOGRAPHICAL POSITION:— It lies between 92.37 to 92.55 East Longitude and 23°101 to 23° 28' North latitude.

BOUNDARY DESCRIPTION: The boundary description of the Range may be given as b.low:

1. NORTHERN SIDE:— The boundary line starts from the confluence of River Tiawng and Changte in the North Western Corner near Lunglei village. It then follows River Changte in South Lastern direction and then it neets River Mawngping near Sialsuk village. The boundary line then follows River Mawngping upto the confluence of River Mat and Mawngping.

- 2. EASTERN SIDE: The boundary line than turns towards the Southerly direction by following the upstream side of River Mat till it meets the Inter-District Administrative boundary line of Aizawl and Lunglei.
 - 3. SOUTHERN SIDE: The boundary line tren follows the Inter-District Administrative boundary line of Aizawi and Lunglei in Westerly direction till it meets river Tlawng near Sertlangpui village.
 - 4. WESTERN SIDE: Lastly, the boundary line follows along the Tlawng River in Northerly direction till it meets the starting point.

GEOGRAPHICAL POSITION: It lies between 92°55'to 93° 3' East Longitude and 23°11'to 23°30' North latitute.

BOUNDARY DETAILS:-

- 1. NORTHERN SIDE: The boundary line starts from the upstream side of Tuirial near Baktawng village and then it flows along the Inter Block Administrative boundary line of Serchhip and Thingsulthliah Block upto the confluence of river Tuivawl Arthladawnlui.
