NOTIFICATION

No. 374/91-CE(PD) /15, the 26th March 1993. Whereas the Department of Power & Electricity, Mizoram, Aizawl a government organisation has proposed to take up the construction of the 8th Plan Transmission Scheme relating to the Establishment, Construction, Operation and Maintenance of Sub-Station and Transmission lines as given in detail.

Whereas under section 29 (2) of the said Act, the the Power & Electricity Department is required to publish the said schemes in the official gazette.

Now, therefore, the Department of Power & Electricity hereby sublish the said scheme in compliance with the said section of Electricity Supply Act, 1948.

SCHEME: 8TH PLAN TRANSMISSI

(A) TRANSMISSION LINES:

- 1. Construction of 132KV Single Circuit line from Kolasib to Bairabi to be charged at 33KV (25Kms.).
- 2. Construction of 132KV Single Circuit line from Khawzawł to Lungdar 'E' to be charged at 33KV (50Kms).
- 3. Construction of 132KV Single Circuit line from Lungsen to Tlabung to be charged at 33KV (25Kms).
- 4. Construction of 132KV Single Circuit line from Khawzawl to Ngopa to be charged at 33KV (60Kms)
- 5. Construction of 132KV Single Circuit line from Saitual to Darlawn to be charged at 33KV (50Kms).
- 6. Construction of 132KV Single Circuit line from Bairabi to Zamuang to be charged at 33KV (20Kms).

7. Construction of 33KV Single Circuit line from Lawngtlai to Tuipang (40Kms.)

(B) SUB-STATION:

- 1. Construction of 132KV/33KV Sub -Station at Bilkhawthlir (Departmental Land Available).
- 2. Construction of 132KV/33KV Sub-Station at Aizawl (Luangmual)-(Departmental Land Available).
- 3. Construction of 33/11KV Sub-Station at Tlabung (Departmental Land Available).
- 4. Construction of 33/11KV Sub-Station at Tuipang (Departmental Land Available).
- 5. Construction of 33/11KV Sub-Station at Ngopa (Departmental Land Available).
- 6. Construction of 33/11KV Sub-Station at Darlawn (Departmental Land Available).
- 7. Construction of 33/11KV Sub-Station at Zamuang (Departmental Land Avaiable).

SALIENT FEATURES OF THE SCHEME:

The scope of work includes erection of 132KV Single Circuit Transmission line at various places mentioned above with switchyard and Sub-Statiou referred above.

LOCATION: At various places above.

ESTIMATED COST: The Estimated Cost of the 8th Plan Transmission Scheme is Rs. 4000 lakhs approximately.

COMMISSIONING SCHEDULE: The whole scheme is likely to be completed within 8th Plan (1997-1998).

BENEFITS: The projects will enable evacuation of Power from Tuirial to Serlui 'B' Badarpur and distribution within Mizoram within the regulation limit. This will give the state more electricity power and will help industrial growth, water suply scheme and many more essential projects.

POWER FOR PLACING TRANSMISSION LINES, TOWERS ETC.

For placing Transmission lines, towers wires, equipments and appliances for the transmission and distribution of Electricity or for Transmission of Telephone or telegraphic communication necessary for the purpose of undertaking, executing and operation of the scheme, the department of Power & Electricity shall in accordance with the provision of Section-42 of Indian Electricity (Supply) Act, 1948 have and shall exercise all the powers which the telegraphic Authority Possesses under Part-III of the Indian telegraphic Act, 1985 with respect to telegraphic lines established or maintained.

Also notice is hereby given, inviting licencees and other persons interested who are likely to be affected to make representations on the schemes to the undersigned within a period of 2(two) months with effect from the date of its publication for consideration.
